## **OVERVIEW AND JOB SUMMARY**

The North Shore Public Health Collaborative (NSPHC) seeks candidates for the position of Regional Public Health Social Worker (RPHSW). The RPHSW will provide programmatic support to build the capacity of participating municipal health departments from the cities and towns of Beverly, Danvers, Lynn, Marblehead, Nahant, Peabody, Salem, and Swampscott.

The position will be based in the City of Salem's Public Health Department, under the management of its Health Agent. The RPHSW will work on a regional basis on priorities identified by the Public Health Directors and Public Health Nurses from all eight participating communities.

## **DUTIES AND RESPONSIBILITIES**

The RPHSW may carry out duties such as, but not limited to:

- Working with the NSPHC group to develop protocols for accompanying housing code inspections and enforcement involving individuals with a hoarding disorder.
- Conducting training for public health staff, including but not limited to Mental Health First Aid and naloxone/overdose prevention and response.
- Fostering relationships with municipal departments, community groups, and organizations, including, but not limited to, hospitals, substance use and mental health care providers, faith organizations, and other organizations addressing the social determinants of health.
- Assisting in the updating and maintaining of resource guides by ensuring information is correct and up to date.
- Providing individual care coordination and referral to community resources.
- Participating in planning, coordination, implementation, and evaluation efforts to improve community health and achieve health equity within and across NSPHC communities.

## QUALIFICATIONS

- Master's in social work and 2 years of experience OR Bachelor's in Social Work and 3 years of experience. Strong social/interpersonal, written, and verbal communication skills. Ability to work independently in a new position. Ability to speak Spanish or Portuguese preferred.
- Valid Massachusetts driver's license required and dependable vehicle or other manner to be mobile within the City, as employee will be responsible for own transportation during to perform this role as needed. Mileage reimbursement available, yet not for Uber, Lyft, the like or any other commercial type transportation.
