READ ALL THE INSTRUCTIONS BEFORE COMPLETING THE APPLICATION

FALSE STATEMENTS

Information provided by the Applicant is done so under the Pains and Penalties of Perjury. Any false statements or information may be grounds for rejection/denial of the license.

INCOMPLETE INFORMATION

Fill out the application completely. Licenses may be denied if information is omitted.

PHOTOGRAPHS

Submit 1 recent passport sized photograph of the applicant with the application.

PAYMENT

Submit a check for the \$100, made payable to "The City of Salem Police Department". This fee is non-refundable. Payment is by cashier's check or postal money order. Credit cards or debit cards are not accepted.

GOVERNMENT IDENTIFICATION

Applicants must produce valid government issued identification.

FINGERPRINTING

Read the enclosed City Ordinance and Salem Police Policy and Procedures pertaining to the fingerprinting of license applicants.

Submit a check for the \$30, made payable to "The Commonwealth of Massachusetts". This fee is non-refundable. Payment is by cashier's check or postal money order. Credit cards or debit cards are not accepted.

Submit a completed and signed "Civil Fingerprinting Consent Form" (supplied in this packet).

SUBMITTING THE APPLICATION

Bring the application, one photograph, two checks, and the signed "Civil Fingerprinting Consent Form" to the Salem Police Department during the business hours of Monday-Wednesday-Friday $4:00\ PM-6:00\ PM$ or Tuesday-Thursday $8:00\ AM-4:00\ PM$, except holidays.

LICENSE ISSUANCE/DENAIL

By Ordinance, the investigation of license applicant must be completed within seven days.

Should an application be denied, an appeal can be made to the City Council.
