The following Order was adopted as amended. The amendments include a motion by Councillor Milo to change the wording of 12 hours to between the hours of 8am-6pm. Councillor McCarthy seconded the motion. The motion was passed. Councillor Sargent made a motion to eliminate Margin Street from this order. It was seconded by Councillor Flynn. The motion passed by a roll call vote of 6 yeas, 5 nays and 0 absent. Councillors Dibble, Dominguez, Flynn, Milo, Peterson and Sargent were recorded in the affirmative. Councillors Furey, Madore, McCarthy, Turiel and Gerard were recorded in the negative. Councillor Turiel made a motion to replace Roslyn Street with Gardner Street. Seconded by Councillor Furey. The motion passed.
