- (b) The licensing authority shall not approve the transfer of the license issued pursuant to this section to any other location but it may grant the license to a new applicant at the same location if the applicant for the license files with the licensing authority a letter from the department of revenue and a letter from the department of unemployment assistance indicating that the license is in good standing with those departments and that all applicable taxes, fees and contributions have been paid.
- (c) If the license issued pursuant to this section is cancelled, revoked or no longer in use at the location of original issuance, it shall be returned physically, with all of the legal rights, privileges and restrictions pertaining thereto, to the licensing authority and the licensing

authority may then grant the license to a new applicant at the same location under the same conditions as specified in this section.

- SECTION 2. (a) The city of Salem shall charge a fee for the license issued pursuant to this act that shall be paid by the licensee at the time of issuance unless the licensing authority agrees to enter into an arrangement with the licensee which would enable the fee to be divided into multiple payments or prorated over multiple periods of time. If the city elects to accept prorated payments over time from the licensee, the option shall be made available, upon request, to all qualified applicants for licensure.
- (b) Any fee collected by the city of Salem for a license converted or granted pursuant to this act that is greater than the amount of the fee charged for an annual renewal of a similar license issued by the city shall be deposited into an economic development account which has been established by the city of Salem and expended by it in a manner consistent with the purposes of the account.

SECTION 3. This act shall take effect upon its passage.

#386 – LEASE AGREEMENT WITH DESTINATION SALEM FOR A VISITOR CENTER IN SOUTH HARBOR GARAGE

The following Order submitted by the Mayor was adopted by a unanimous roll call vote of 11 yeas, 0 nays and 0 absent.

ORDERED: The Mayor is hereby authorized to enter into a lease agreement with Salem Office of Tourism and Cultural Affairs, Inc. d/b/a Destination Salem for the use of a 1,256 square foot office at the South Harbor Garage. Destination Salem, the sole proposer in response to the City's 2021 Request for Proposals, shall use the space for as a Visitor Center and office. In an addition to lease payments, Destination Salem shall incur the expense of designing and constructing the space for its use and maintaining and supplying products for public restrooms the City is constructing adjacent to the leased space. The lease, as approved by the City Solicitor, shall be for an initial term of five years with an option to renew the lease for up to five additional one-year periods. (See back-up for complete RFP)

Councillor McCarthy stated he is glad that there will be physical presence in that garage and will have restrooms in that area. This will greatly enhance the garage and the area.

Councillor Dominguez stated it will be very beneficial to have them in that area. Would like to hear more details on revenue.

Councillor Madore reviewed the very thorough RFP from Destination Salem. Putting in their own money to clean and staff bathrooms. It is a great proposal and a great partner to have.

Councillor Morsillo stated the RFP was in the back up materials. Monthly rent of \$400. Paying for their own facilities. City pays for bathroom. Not a lot of money for the city because Destination Salem will be taking care of bathrooms, which will be cleaned three times a day or more during busy times.

Councillor Dibble in support of this. Stalls at artist row – one was converted into bathrooms this was phase one. Phase two was to be somewhere closer to Pickering Wharf. Thanks Destination Salem for stepping up.

Councillor Riccardi supports this. It is a win-win-win. Page 29 of RFP gives projected budget. They will be providing a needed service in that area. Hopefully it will be open for the October season.

#387 – NAMING OF VETERANS SQUARE AFTER US ARMY STAFF SGT. WALTER MIELCARZ

The following order introduced by Councillor Riccardi was adopted.

ORDERED: That a Veteran's Square be named after US Army Staff Sergeant Walter Anthony Mielcarz who was killed in action in France on September 18, 1944 and that Mielcarz Square be located at the corner of Grove and Tremont Streets.

#388 - NAMING OF RIGHT OF WAY BETWEEN 15 & 19 FRONT ST - HOUDINI WAY

The following order introduced by Councillor Madore was adopted.

ORDERED: That the Right of Way between 15 and 19 Front Street shall hereafter be named "Houdini Way" in honor of Harry Houdini who, in April of 1906, performed an extraordinary escape from handcuffs and a locked cell at the former police station at 15 Front Street.

#389 - B&S FITNESS ROAD RACE AND USE OF CITY STREETS SEPTEMBER 19, 2021 - WICKED HALF MARATHON

The following Order introduced by Councillor McCarthy was adopted (due to late file).

ORDERED: That the attached road race application for B&S Fitness to hold their Wicked Half Marathon and use of city streets on September 19, 2021, be referred to the Committee on Public Health, Safety and Environment co-posted with the Committee of the Whole.

#390 - DISCUSS FORMER WARD 2 SOCIAL CLUB ISSUES

The following Order introduced by Councillor Dibble was adopted (late file).

ORDERED: That the Committee on Community and Economic Development co-posted with the Committee of the Whole, meet to discuss and make recommendations on the former Ward 2 Club property at the intersection of East Collins Street and Planters Street to include the following:

- 1. The building demolition has resulted in an unsafe 3-4' depth pond and te perimeter safety fence is not secure and open on one side.
- 2. The former Building's pond has caused an explosion of mosquitos to breed and impact the neighborhood.
- 3. The safety/construction fence is unsafe as located along the street, and the sidewalk was illegally removed. Determine if fence should be moved back onto the private property and require owners to replace sidewalk along East Collins Street.
- 4. Determine if the City of Salem can issue a building permit and whether or not the use meets the requirements of the Dover Amendment and Chapter 40A with a Detox Center being allowed in a tight residential neighborhood and with the area flooding frequently.

And that the City Engineer, Building Inspector and Solicitor be invited.

#391 – MEET TO DISCUSS WATER MAIN BREAKS

The following Order introduced by Councillor Dibble was adopted (late file).

ORDERED: That the Committee on Government Services co-posted with the Committee of the Whole meet with the City Engineer to discuss the following matters:

- 1. The large number of water breaks happening throughout Salem and the cause of these breaks, and what can be done to reduce the breaks.
- 2. The cost of these water line break repairs is extremely expensive and determine ways to reduce this cost.
- 3. Many basements have been flooded, some with raw sewerage. Determine ways to stop this from happening and to speed up the reaction time of the City to help the Salem residents faster that are being flooded.
- 4. To recommend actions needed to be taken and report back immediately to the City Council for action.

#392 - MEET TO DISCUSS DOG WASTE AND FINES

The following Order introduced by Councillor Dominguez was adopted (late file).

ORDERED: That the Committee on Public Health, Safety and the Environment, coposted with the Committee of the Whole, meet to discuss and determine ways to require dog walkers to cleanup their dog's waste including possible installing dog waste signs in public spaces, increase fines to those that violate the ordinance and other actions as recommended.
