## \#456 - ACCEPT MGL CH. 40, SEC. 13E TO ESTABLISH A SPECIAL EDUCATION STABILIZATION FUND

The following order submitted by the Mayor was adopted by a roll call vote of 10 yeas, 0 nays and 1 absent. Councillors Cohen, Dominguez, Hapworth, McCarthy, Merkl, Prosniewski, Riccardi, Varela, Watson-Felt and Morsillo were recorded in the affirmative. Councillor McClain was recorded as absent.

ORDERED: That the City accept the provisions of Massachusetts General Laws Chapter 40, Section 13E, in order to establish a Special Education Stabilization Fund to be utilized in upcoming fiscal years, to pay for unanticipated or unbudgeted costs of special education, out-of-district tuition or transportation in accordance with the recommendation of Her Honor the Mayor.

This fund was discussed by the Supt. and Finance Director during the School's budget meeting. This is to give the School Department more flexibility. Having a stabilization fund allows money to be rolled over instead of ending that fiscal year. So if don't need it one year it rolls over and then the money would be available for another year it is needed. It will bring additional help for children that need it.

## \#458 - SOLAR AGREEMENTS TO FACILITATE THE INSTALLATION OF SOLAR PANELS AT COLLINS MIDDLE SCHOOL AND SALTONSTALL SCHOOL

The following order submitted by the Mayor was adopted by a roll call vote of 10 yeas, 0 nays and 1 absent. Councillors Cohen, Dominguez, Hapworth, McCarthy, Merkl, Prosniewski, Riccardi, Varela, Watson-Felt and Morsillo were recorded in the affirmative. Councillor McClain was recorded as absent.

ORDERED: The Mayor is hereby authorized to execute solar agreements including the Power Purchase Agreement, Lease, Notice of Lease and all documents necessary to facilitate the installation of solar panels at the Collins Middle School and the Saltonstall School.

Councillor Riccardi stated this has gone through a lengthy process and the school committee voted unanimously in favor of this project. And this project follows are goals of the City for Clean Energy.

Councillor Cohen requested and received suspension of the rules to allow Mr . Woodman to speak.

Councillor Cohen asked Mr. Woodman about Saltonstall School and the roof not being structurally sound enough, Was this factored into the PPA?

Mr. Woodman replied that the original plan included all available areas. The Structural Engineer given us specific areas that need to use different types of attachments and get incorporated into the plans and weight load.

Councillor Cohen asked if this requires more structural work is that going to be factored into the PPA or is this something the City has to do?

Mr. Woodman stated that if there was more structural work it would have been identified, but yes, it would have prevented solar panels going on certain areas of the school and that work would have been incorporated.

Councillor Cohen asked what was the term of the PPA, if there was any escalator each year, and what was is the rate.

Mr. Woodman answered that the term was for 20 years, there was no escalator and that at Collings the rate is $\$ 0.94$ per kw/hr versus $\$ 0.14$ from utility company and the rate at Saltonstall is 10.262

Councillor Cohen stated these are good rates and terms. Most PPAs have an escalator clause. He is really excited and wish we could put solar panels on all buildings.

Councillor Dominguez commended the city for doing this project. He asked why these buildings and not others such as the Police or Fire Station?

Mr. Woodman responded when work with a City there are tons of available space, but different factors go into deciding which buildings work best i.e. structural components, roof's age, forecast of roof work, etc. When put all together some emerge on top. The high school was phenomenal but too much work being forecasted in the future.

Councillor Watson-Felt asked how often are assessments done on city properties?
Mr. Woodman replied over the last year walked the roofs of most of the schools doing the structural components. Looked at parking lots as possibilities. Also compared our rates versus existing rates to see if there would be a savings.

Councillor Cohen stated in 2015 the city commissioned a feasibility study of twenty-two buildings in Salem. The City uses about 11 megawatts of electricity and on these buildings if in a perfect ideal situation we could do about 5 megawatts. So to reinforce what was said you go for the biggest real estate possible. This was the high school, but it needed structural work.

## RESOLUTION: Certified Project Application \& Tax Increment exemption Agreement for 5 Broad Street

WHEREAS, the City of Salem has been in negotiation with 5 Broad Street LLC regarding a development consisting of fifteen units of market rate housing, one unit of affordable housing reserved for families earning less than 60 percent of median area income at 5 Broad Street;
WHEREAS, 5 Broad Street LLC has applied for certification under the Massachusetts Housing Development Incentive Program created by Chapter 40V of Massachusetts General Laws;
WHEREAS, the project proposed by 5 Broad Street LLC meets the minimum requirements of the Housing Development Incentive Program and the local objectives of the City of Salem's Housing Development Zone Plan;

WHEREAS, the proposed project is located at 5 Broad Street, Salem, MA, which is within the boundaries of the City of Salem's designated Housing Development Zone;

WHEREAS, the City of Salem has agreed to offer 5 Broad Street LLC a Tax Increment Exemption Agreement. Said agreement is hereby approved by the City Council;
WHEREAS, 5 Broad Street LLC is investing $\$ 7.6$ million to create 16 total units of housing;
NOW, THEREFORE, BE IT RESOLVED that the Salem City Council hereby approves the Certified Project Application of 5 Broad Street LLC and forwards said application to the Massachusetts Department of Housing and Community Development for its approval and endorsement.
Further, the Salem City Council authorizes the Mayor to execute the Tax Increment Exemption Agreement between the City of Salem and 5 Broad Street LLC. Said agreement will provide for an exemption on property taxes based on the growth portion in assessed valuation of the property for a period of five (5) years, beginning the first full fiscal year after the final residential Certificate of Occupancy is issued for the new building at 5 Broad Street, and in accordance with the schedule below:

Said exemption being in accordance with the requirements and regulations established, which govern the implementation of such Tax Increment Exemption Agreements.

Councillor Riccardi stated that Amanda Chiancola, our Asst. Planner, is available for any questions. We have done similar TIFs for commercial projects; this is for housing. It allows the city to forgo a portion of property taxes on the new growth. There is no net loss in tax revenues it is just a slower uptick on collecting on the full value based on the above chart. This is the minimum amount to pay their tax state credits. The developer must first enter into the TIF agreement with the city, which is in front of us this evening.

Councillor McCarthy stated we believe in this project and it allows the developer to go after more funds with the sate and to secure funding. The Council voted for Municipal Reuse Ordinance; this is a good example. Please save the Bell Tower.

Councillor Cohen said this is a historic building that is unsafe and will now be turned in housing that is great and this is a very sustainable project.

The experimental Safety Zones shall be in effect for a period of sixty (60) days from the time appropriate signage has been installed.

Councillor Dominguez stated there were a lot of changes here. Like to see final effort or say of businesses and residents since 2019 to refresh their mind. Like to see this put into Committee.

Councillor Cohen stated that Councillor's Riccardi details were tremendous and all the public input was an impressive body of work.

Councillor Merkl appreciated the work of traffic and parking but also the public input.
Councillor Dominiguez made a motion to refer this to the Committee on Ordinances, Licenses and Legal Affairs. There was no second.

Councillor Riccardi state that we know what the sticky points are but need to move forward. In 2019 there were less businesses and now there are more and active areas

## (\#384) - ORDINANCE AMENDING RATES FOR USE OF WATER

The Second Passage of an Ordinance to amend an Ordinance relative to Rates for Use of Water was adopted for second and final passage.

Section I. Chapter 46, Section 66 is hereby amended by deleting subparagraph (b) in its entirety and replacing it with the following:
"(b) The rate for all water furnished by meter measurements effective July 1, 2022, shall be as follows:
(1) Residential, per 100 cubic feet $\$ 3.72$
(2) Nonresidential, per 100 cubic feet $\$ 5.04$

Section 2. Chapter 46, Section 66 is hereby further amended by deleting subparagraph (e) in
