Resolved: Having convened in an open meeting March 26, 2020 prior to the SOI submission closing date, the City Council of Salem, Massachusetts, in accordance with its charter, by-laws, and ordinances, has voted to authorize the Superintendent to submit to the Massachusetts School Building Authority the Statement of Interest Form dated no later than May 6, 2020 for the Salem High School located at 77 Willson Street, Salem, MA 01970 which describes and explains the following deficiencies and the priority category(s) for which an application may be submitted to the Massachusetts School Building Authority in the future:

- Replacement or renovation of a building which is structurally unsound or otherwise in a condition seriously jeopardizing the health and safety of school children, where no alternative exists.
- Replacement of or addition to obsolete buildings in order to provide for a full range of programs consistent with state and approved local requirements.
- Replacement, renovation or modernization of school facility systems, such as roofs, windows, boilers, heating and ventilation systems, to increase energy conservation and decrease energy related costs in a school facility.

And hereby further specifically acknowledges that by submitting this Statement of Interest Form, the Massachusetts School Building Authority in no way guarantees the acceptance or the approval of an application, the awarding of a grant or any other funding commitment from the Massachusetts School Building Authority or commits Salem, MA to filing an application for funding with the Massachusetts School Building Authority.

**Section 1.** Section 88 – Speed Zone Regulations of Article VIII be amended by repealing the following:

Valley Street – eastbound, beginning at the junction of Gallows Hill Road, thence easterly 0.15 miles at twenty-five (25) miles per hour, 0.18 miles at thirty-five (35) miles per hour, 0.18 miles at twenty-five (25) miles per hour, ending at the junction of Route 107, Highland Avenue; the total distance being 0.51 miles. (2/25/76 DPW 1019)

## And replacing it with:

Valley Street – eastbound, beginning at the junction of Gallows Hill Road, thence easterly 0.15 miles at twenty-five (25) miles per hour, 0.18 miles at thirty-five (30) miles per hour, 0.18 miles at twenty-five (25) miles per hour, ending at the junction of Route 107, Highland Avenue; the total distance being 0.51 miles. (2/25/76 DPW 1019)

**Section 2.** Section 88 – Speed Zone Regulations of Article VIII be further amended by repealing the following:

Valley Street – west bound, beginning at the junction of Highland Avenue, Route 107, thence westerly, 0.18 miles at twenty-five (25) miles per hour, 0.18 miles at thirty-five (35) miles per hour, 0.15 miles at twenty-five (25) miles per hour, ending at the junction of Gallows Hill Road; the total distance being 0.51 miles. (2/25/75 DPW 1019)

#### And replacing it with:

Valley Street – west bound, beginning at the junction of Highland Avenue, Route 107, thence westerly, 0.18 miles at twenty-five (25) miles per hour, 0.18 miles at thirty-five (30) miles per hour, 0.15 miles at twenty-five (25) miles per hour, ending at the junction of Gallows Hill Road; the total distance being 0.51 miles. # #197 - MAYOR ADDRESS COUNCIL REGARDING COVID-19 OUTBREAK

The following communication from the Mayor to address the City Council on March 26, 2020 to provide the public and the Council with an update on the City's response to the COVID-19 outbreak was received and filed.

The Mayor and Health Agent David Greenbaum gave the following update. The amount of positive cases in Salem as of March 26, 2020 was at 14 and the process that is followed when a person develops symptoms, what the city's response has been, what areas have been determined response specific, overview of what Salem Together is

doing and how to sign up, update on Salem public schools and meal programs, and common questions.

Councillor Dominguez asked how are we getting the number of cases in Salem. Important to know so people do not take this lightly. City should have a list of essential business. Many of our businesses are small mom and pop stores. The Mayor responded we are following the same list the state put out.

Councillor Hapworth was concerned about the Parks and Playgrounds. Still seeing groups gather at these places. No social distancing. The Mayor responded all parks and playgrounds are shut down, signs are posted. Will look into taking the hoops down for now because nicer weather will bring out more people or maybe some caution tape. David Greenbaum stated if you see gatherings call the Park & Rec, Board of Health or the police.

Councillor Madore – Asked about unemployment assistance especially servers. System is difficult to navigate is there anyone at the local level to help these people sign up? Business owners are worried about evictions. We as a City urge building owners to give relief to tenants during the next few months. Mayor responded Tom and Kate are brainstorming ideas how to revitalize downtown at the end of this.

Councillor Dibble stated that the Mayor and other leaders are doing a great job. Wanted to know where the \$250,000 is going. The Mayor responded we don't have a list but need the resource to spend money now until we get reimbursed. It will cover such items as equipment for first responders, cleaning equipment to disinfect buildings, etc.

Councillor Riccardi echoed her thanks as well. State many people still using parks in her Ward also.

Councillor Prosniewski want to mention the bright spots as well. That most people recover from this. Do we have any numbers to show the positive as well? David Greenbaum responded that there is not enough tests to go around to get these real numbers.

Councillor Flynn asked if the bike rental and scooter program has been suspended. The Mayor responded that the Bike rental is still up and running due to students and people in general trying to get around. They are being sanitized.
