## #503 - ORDINANCE AMENDING FORTUNTELLING LICENSES

The following ordinance introduced by Councillor Watson-Felt was adopted for first passage.

### In the year Two Thousand and Twenty-Three

An Ordinance relative to store fortunetelling licenses

Be it ordained by the City Council of the City of Salem, as follows:

**Section 1.** Chapter 14, Division 2, Sec. 14-73. - *Licensing board authorized to license* I s hereby amended by deleting sub-section b) in its entirety and replacing it with the following:

"b) Store licenses. The licensing board may issue store licenses. Only one store license may be issued per business address or in the case of a multi-unit building, only one store license may be issued per unit. A store license shall license the owner of an establishment to employ, in addition to the store owner, up to ten employees to engage in the enterprise of fortunetelling, upon the premises of the licensed store. The employee shall be considered a sublicensee and shall only be considered licensed so long as the employee is employed by the holder of the store license. Only five sublicensees may be employed within the store on the same day and time. Upon the discontinuance of employment at the licensed store, the employee shall no longer hold a valid fortunetelling license. Licenses shall be framed and prominently displayed in the store and made available for inspection. Sublicensees shall be considered employees of the store unless they qualify as a contractor pursuant to M.G.L. Chapter 149, Section 148B."

**Section 2.** This Ordinance shall take effect as provided by City Charter.

Councillor Watson-Felt explained that the last line was added so it states that they are treated as employees and not I-9s. This is not increasing the number of fortunetellers it just allows more to go through their CORI checks and get vetted in case someone needs to fill in or different employees work different days.

### #505 - ORDINANCE RELATIVE TO BALLOONS

The following order introduced by Councillor Varela was adopted.

**ORDERED:** That the Public Health, Safety and Environment Committee co-posted with the Committee of the Whole meet discuss the following ordinance amendment to be adding a new section 31 to Chapter 24 – OFFENSES AND MISCHELLANEOUS PROVISIONS:

No person shall sell, use or distribute any type of balloon (including, and not limited to, plastic, latex or Mylar balloons) inflated with any type gas including air (including, and not limited to, helium gas). No person shall dispose of any balloon in any manner, including by release into the air, other than being contained in a plastic trash bag and transported to the cities contracted trash service. and that hot air balloons and balloons used for scientific purposes by a scientific or government entity are exempt. Any person violating this bylaw shall be fined noncriminal disposition at \$50 per offense. This bylaw may be enforced by any police officer of the City of Salem.

There have been other U.S. coastlines that have adopted this or similar ordinances. This has also been brought forward on the State level. Balloon waste has dangerous impact on ocean life. Balloons can even suffocate a whale.

#### #506 - CONDITIONS FOR UTILITY COMPANIES

**ORDERED**: That the following conditions be placed on the Utility Companies grant of locations:

"Conditions: No construction allowed until required permits are obtained. Complete application for the Street Opening & Trench Permit must be submitted at least 7 days prior to proposed start-of-work date. Refer to "Street Opening Rules & Regulations" for complete requirements through the City Engineer's Information for Drainlayers page. Requirements include that all structures installed within public right of way shall be AASHTO H20 rated, and that sidewalks must be replaced in kind."

Councillor Morsillo explained these are updated conditions from what the City Clerk's office adds to these grants of locations. The Engineering Department reviewed the language and gave their input. Since this is a reoccurring condition from Engineering, this order makes it permanent until further notice. And Councillors will not have to state this each time as a condition. Only conditions that additional will need to be done on the floor.

Councillor McClain offered the following report for the Committee on Administration and Finance co-posted with the Committee of the Whole. It was voted to accept the report and adopt the recommendation. The matter was adopted by a roll call vote of 10 yeas, 1 nays and 0 absent. Councillor McClain was recorded in the negative.

The Committee on Administration and Finance co-posted with the Committee of the Whole to whom was referred the matter of an Order to Approve the Certified Project application for 38 Norman St. QOZB, LLC and to authorize a TIE (Tax Increment Exemption) Agreement has considered said matter and would recommend this matter be adopted by roll call vote.

Councillor McClain stated the committee went through other projects and discussed what made this one worthy. Heard some concerns about any conflict between creating housing and authorizing a TIE agreement with a private entity. We wanted to ask questions to make sure we are using this tool wisely.

Councillor Cohen stated another benefit to the community. The Rental stock is decreasing and there is a lack of smaller units. At least one or two of units committed to rental units.

Councillor Watson-Felt took umbrage the former Ward 2 Councillor about lack of information. We are elected officials who do not know how to navigate this system or works in an industry that is in the business of doing this. This is a private-public venture. HDIP exists and has the right to take this path. It's well within their rights. Since this is a private entity, it is fair to have a conversation about it. Two units will be maintained as affordable unit for 99 years.

Councillor Hapworth walked in as a no wanting it to be a yes. With this conversation being held and Amanda talking about the size and small scale developers, the 22 units fit into that neighborhood, so he can now stand behind it.

Councillor Merkl appreciated tonight's discussion. Look at our rental stock and those being affordable within that stock. The Developers worked with and listened to the neighbors and made changes. We want to create housing with input and affordability.

Councillor Morsillo in favor of this. Good Housing especially in that area. It's a mess there now. It will be minimal decrease in taxes to help them get funding.

Councillor McCarthy state there is a public process and the did their due diligence. It's always easy to second guess a Councillor who previously sat in this chair. It could have been the situation at that time. They need this minimum tax relief to get additional funding. How we act is doing the best for the city. Do you now how hard it is to pencil

out a project in today's date and age? The Council wouldn't approve it if doesn't make sense or the project doesn't work for the developer. There is no guarantee that the State will give them money.

Councillor Prosniewski stated this new development is the way we should be development. Community gives input and the City receives more housing.

#### (#483A) SECOND PASSAGE – WAGE THEFT ORDINANCE

The Second Passage of an Ordinance relative to Wage Theft was adopted for second passage. (Below is a summary – Full Text can be found in the City Clerk's office during normal business hours)

#### **Wage Theft Prevention Summary**

**Purpose.** To protect workers wage theft, the improper withholding of payment from employees and failing to pay them according to required schedules; ensure City vendors comply with wage laws and that City resources are not used to support vendors responsible for wage law violations; and ensure that potential and current recipients of tax relief agreements and licenses issued to restaurants do not violate the wage laws.

**Wage Theft Compliance Process.** The City Solicitor's Office shall create an online complaint form that affected employees may use to report complaints and violations. The reports shall be filed with appropriate agencies and city officials.

#### **Requirements for Contractors.**

Every bid issued by the City shall notify bidders/proposers that they have an affirmative duty to report any judgment or debarment for wage within the five (5) years prior to bid submission and may not contract with the City if they have been either voluntarily or involuntarily debarred for wage theft unless the case is resolved, fees paid, and a bond posted. City contractor shall properly classify employees as employees rather than independent contractors and treat them accordingly for purposes of prevailing wages

and overtime, workers' compensation insurance coverage, taxes. If a Contractor is found to be in violation, the City may revoke, suspend or condition the contract.

### **Requirements for Tax Relief Agreements**

Each Tax Relief Agreement entered into between the City shall require recipients 1) certify that they shall not engage any entity to perform work on the project who is subject to any debarment for wage theft and other labor laws, including workmen's compensation, with past five years; 2) maintain appropriate industrial accident insurance; and 3) properly classify employees as employees rather than independent contractors and treat them accordingly for purposes of workers' compensation insurance coverage, unemployment taxes, social security taxes and state and federal income tax withholding. If the recipient is found to violate the wage laws, the City may seek to terminate the agreement.

### Requirements for Licensees and Prospective Licensees.

Any application filed with Salem Licensing Board for a c. 138 or c. 140 license may be denied if there is a judgment or debarment from a violation of laws regulating the payment of wages.

License issued by the Salem Licensing Board may be modified, suspended or revoked if the licensee has been found to have violations of laws regulating the payment of wages.

Employers granted a License or Permit that have disclosed a judgment or debarment resulting from a wage law may be required to obtain a wage bond or other form of suitable insurance.
