AH: I have lived near the common since 1995 never seen so much damage to the grass, so much foot traffic every day. This never had happened before. The layout of the rides and vendor tents didn't do as much damage as foot traffic. No grass left on the common. Criticism is that grass would be replanted. I am very pleased with restoration being done as we speak to restore grass. The reason grass has never grown well is because of the abundance of Norway Maples, toxic to ground cover.

According to Naomi Cottrell. We need to reevaluate allowing so much traffic on the common. The grass has done fine when only used for a few days at a time. DC has done a great job of rehabbing National Mall. My hope is we wont spend too much money and time fixing the common in the future. Salem Common belongs to everyone to take care of.

TO: Had a great meeting last night with park and rec commission approving various trees, along with some larger trees. Were able to do a lot of tree pruning leading up to the muster. Having received some grant funding we have done many improvements. Last year we added many accessible benches. With some of earmark funding we will have a chance to make some improvements, we have done some research into protective padding. I would like to give a shout out to our parks crew and DPW. FB makes it brutally tough Many of these measures may prevent damage to the grass. A lot of shade, hard to grow grass in the front

ET: hardscape will make the area more unified, without worrying about grass

AM: Would love to know more about protective padding, is it practical?

RJ: Forreststry supply, translucent mat allows sun to reach grass. Wont kill grass, matt can stay down for five days. \$244 per pad, looking to 39k purchase, 41k total purchase

DK: Shares graphic showing placement of matts

DM: Many events longer than 5 days, why not just expand paths

DK: Cost and flexibility

DM: How long do these events last? Isn't it longer than 5 days

ET: dependant on weather

CWF: pads question. How do they function with mud when there is a deluge of water such as last year. One of the learnings last year. It was dry when tires went on. Then turned to mud. I'm wondering if these will still do their job. What makes these better than the other products that I've seen, those hexagonal tracks that I've seen. Are these better?

DK: Do you mean the geogrid? We did look at that. We thought these mats would give us more flexibility. We considered them, they are expensive, this gives us more flexibility.

CWF: Why not permanenant? Flexibility for what purpose?

DK: we can move them around, we can stack them in one area or spread them out.

CWF: How do pads work with regard to mud?

DK: I don't think there will be an issue, youre still dispersing mud of tires, need inclement weather plan.

CWF: can they work more than 5 days?

DK: Manufacturer says 5 days, it's october

CWF: Fees and funds. Can I understand the fees for use of common. Does it make sense to look at . . Not all events are equal. Some have more taxing effect than others. Have we considered any additional fees to offset damage. Don't want to hurt small business, curious if there is an oppty for something larger

TO: demand is getting higher, smaller events are generally interested, but getting bigger. Don't want it to be unfeasible, we have always incorporated 5%, turned into revolving fund.

ET: I can speak to October, what happened in October, vendors were moved. City goes out for RFP for people to manage these events. But they are our events. There is a manager for these events. We realize there is wear and tear, need to balance with using the Common as an open space.

CWF: I think it's a good model to subcontract for all kinds of events. I think the model is a good one. We can invest in these pads or tracks. We can expext they will be utilized.

TO: could be used at other parks as well

CWF: good conversation about how our parks are cared for

AH: It was the month long exposure to foot traffic that was most damaging that was from concerts. Don't forget all of that needs to be approved by Historic Commission

DM: Sometimes vendors deliver goods in carts not trucks. Are we going to make our way toward that.

ET: driving on common. Two permits are given, I make those permits

AM: Appreciate all being mindful of what events we get, app

DM: pleased with Naomi's presentation. Pattern to see replacement trees as Norway Maples come down, eliminates gaps
