SALEM HISTORICAL COMMISSION

ANNUAL REPORT JULY 1, 2009 - JUNE 30, 2010

The Salem Historical Commission is a volunteer board of Salem residents appointed by the Mayor. The Commission's mission is to provide regulatory design review within Salem's four designated local historic districts. The Commission also provides community-wide historic preservation planning assistance by promoting historic preservation awareness and by commenting on projects that may impact historic resources.

Certificates Issued

During the year July 1, 2009 through June 30, 2010, the Salem Historical Commission met 23 times during which a quorum was present. In its capacity as Historic District Commission for 4 local districts, the Commission received 158 applications and filed a total of 169 certificates including:

- 65 Certificates of Appropriateness;
- 3 Certificates of Hardship;
- 93 Certificates of Non-Applicability;
- 6 Waivers of the Demolition Delay Ordinance;
- 1 Denial for a Waiver of the Demolition Delay Ordinance; and
- 1 Denial for Certificate of Appropriateness.

Certificates issued are provided to the owner of the property, the City Clerk and the Building Inspector and are kept on file in the Department of Planning and Community Development according to address. A list of all Certificates issued can be found in the Certified Local Government Annual Report, which is on file at the Department of Planning and Community Development and the Massachusetts Historical Commission. Commission Members

The Commission is regularly comprised of seven (7) regular members and two (2) alternate members. Douglas Desrocher resigned on May 19, 2010 and on May 26, 2010 a letter was sent to the North Shore Association of Realtors requesting nominations for realtors who reside in Salem. A response with two nominations was received on June 24, 2010 and the process is underway to appoint one of the nominees. As of June 30, 2010, there are two full member vacancies.

Grant Awards

A \$15,000 Massachusetts Historical Commission Survey and Planning Grant was awarded in March, 2010 for a project to commence in September, 2010 to undertake a historic property survey of Bridge Street Neck.

The City received \$305,977 in American Reinvestment and Recovery Act funding which was used to provide historically compatible handicapped accessibility improvements to City Hall.
