### Fall Meeting Hosted by Social Security Administration

The September, 2010 Salem HOPE meeting was hosted by the Social Security Administration. Representing the agency was Thomas Savage, District Manager, along with Janine Lang. Present were Jane Guy of the City of Salem DPCD, Lucy McKinnon of North Shore Elder Services, Deric LePard of NSCAP, Ava Amini of the Children's Law Center of MA, Kimberly Jones and Charlene Snow of the North Shore Career Center, Anne-Marie D'Angelo Florent of MassHealth, Mary Margaret Moore and Diane Speicher of the Independent Living Center, Maureen Fiore and Barbara St. Pierre of Cerebral Palsy of Eastern Mass., Mary Sholds of the Salem YMCA, Jane Williamson and Teury Marte of Massachusetts Rehabilitation Commission, and Sonya Snow Parish of the North Shore Community College Adult Learning Center.

Mr. Savage welcomed the group and stated that on August 14, 1935, President Roosevelt signed in law the Social Security Act to protect citizens from loss of jobs and from poverty in old age. The <u>Social Security Administration</u> provides retirement benefits, benefits for survivors and their children and benefits for the handicapped. It is also the face of Medicare and for the provision of Supplemental Security Income (SSI). He stated that the Salem office is a full service office, but noted that more and more services are offered on line. They will soon be releasing a Spanish retirement estimator. Retirement benefits can be accessed at age 62 or a person can wait for full retirement, usually at age 67. A disabled person can start collecting after the process is cleared, which typically takes 4-6 months from time of application.

Ms. McKinnon stated that <u>North Shore Elder Services</u> provides home care for elders, case management. They also provide supportive living services at 27 Charter Street.

Mr. LePard stated that he is the Director of Advocacy at <u>NSCAP</u>. He stated that fuel assistance is getting in to swing and that last year they served 6000 households. New applications start 11/4/10. He noted that they have HPPO dollars for individuals at threat of imminent homelessness.

Ms. Snow-Parish stated that the North Shore Community College <u>Adult Learning Center</u> provides a GED program and the Cummings Center in Beverly. This year, they are trying a new GED drop in class on Monday and Thursdays from 2-3:30. Applicants need to get on a wait list first, but there are no attendance requirements.

Ms. Marte stated that <u>MassRehab</u> works with individuals with disabilities by providing skills training, college tuitions, etc. They are seeking a rehabilitation counselor.

Ms. Williamson of MassRehab stated that the bottom line is employment and that they have a new initiative to hook people up with employers.

Ms. Sholds stated that the <u>Salem Y</u> provides financial assistance for member and for afterschool care. They also have a Teen Program that helps keep teens of the street and out of trouble.

Ms. Amini stated that the <u>Children's Law Center</u> provides legal services and training on children's issues and rights.

Ms. Moore stated that the <u>Independent Living Center</u> is a voice for any person with any disability. They serve 25 communities, offering information and referral and working as peer guides to help individuals reach goals to live as independently as they choose. They have a new Long Term Care Options Program with which they are partnering with various providers of senior services. Ms. Speicher specializes in housing.

Ms. D'Angelo Florent stated that <u>MassHealth</u> is doing member education. She noted that there are over one million members on MassHealth and that MassHealth will train people who work with their population.

Ms. St. Pierre stated that she is from the North Shore Infant and Toddler Program's Lynn office. Ms. Fiore stated that she is from their Salem office. The new website is <u>cpemass.org</u>. They assist 0 to3 year olds on the North Shore who are at risk of developmental delays. They also offer parent education and support.

Ms. Snow stated that she provides business services at the <u>North Shore Career Center</u>. There is a new A. J. Wright opening at the end of October in Salem. They are recruiting for 100 people, mostly part time. There will be a fall job fair in September.

Ms. Jones stated that she provides outreach and marketing for North Shore Career Center. They are a free one-stop career center. They now have Employment Express, a grant-funded transportation program to the Route 114/Route 1 corridor.

Ms. Guy of the <u>City of Salem</u> Department of Planning & Community Development stated the public comment period for the City of Salem's Consolidated Annual Performance and Evaluation Report runs through September 24<sup>th</sup>. She reminded the group to forward event notices, job openings, etc. to her and she will either forward them on to the Salem HOPE email distribution list or include it in an upcoming newsletter.
