Salem YMCA hosted Autumn Meeting

The September, 2011 Salem HOPE meeting was hosted by the Salem YMCA. Representing the agency was Executive Branch Director Mari Matt. Present were Jane Guy of the City of Salem DPCD, Barbara St. Pierre of North Shore Infant & Toddler Program, Sonya Snow-Parish of North Shore Community College, Jacqui Curcio of HealthQuarters, Lisa Rose of the Independent Living Center, Barbara Reeder of NSCAP, Anne Marie D'Angelo Florent of MassHealth, Myra Terry and Teury Marte of Mass Rehab Commission, Joy Winkler of the North Shore CDC, Gail Kelley of Morgan Memorial Goodwill Industries, Charlene Snow of North Shore Career Center and Julia Westley of the Children's Law Center.

Ms. Matt stated that she has been the Branch Executive Director for approximately one month. The Salem YMCA has a fitness center, a child care center and a teen center. She is working with other agencies to help fit their mission and find ways that the YMCA can help. They offer programs for preschool, youth development, tutoring, college prep, swimming lessons and Tae Kwon Do. Their teen program allows memberships for teens at a reduced cost, based on household income. She noted that all branches of the YMCA of the North Shore have financial assistance programs. The

undergoing a capital campaign to repurpose the YMCA as a creative art center. They are restoring the gym as the theatre. The goal is to incorporate arts in the building, including painting studies and pottery.

Ms. Kelley stated that <u>Morgan Memorial Goodwill Industries</u> provides jobs skills and training to individuals with disabilities with the goal of finding competitive employment. They are in partnership with Stop n' Shop's Peapod operation. They have a new H.E.L.P. Program to help people to be able to be placed in the human services area.

Ms. Curcio of <u>Healthquarters</u> stated that they have a clinic at their Beverly location. They provide GYN exams, birth control, emergency contraception, counseling and pregnancy and HIV testing.



Click on the logo for information on the North Shore YMCA Theatre Company's production. Ms. Snow stated that she provides outreach to employers for the <u>North Shore Career Center</u>. They have job fairs coming up in September and November. The have a youth center in the Lynn office.

Ms. Marte stated that <u>Massachusetts Rehabilitation Commission</u> just got fully staffed with counselors. They work with people with disabilities to try to get them back into the labor market.

Ms. D'Angelo Florent stated that <u>MassHealth</u> is eligibility based. She is the member education representative and will visit agencies.

Ms. Snow-Parish stated that the <u>North Shore Community College Adult Learning Center</u> is at the Cumming Center in Beverly. They have four levels of GED classes. They are turning into a drop-in center for a couple hours of the week for students on the waitlist who test to GED level (9th grade reading level or higher).

Ms. Reeder stated that NSCAP has two sites in Peabody. They offer 3 levels of ESOL classes. She stated that she assesses what level to place an individual. Level 1 has the longest wait list (6-12 months). NSCAP also offers fuel assistance. Any household that got fuel assistance last year will receive an application for this year. New applicants can call to make an appointment.

Ms. Rose stated that the <u>Independent Living Center of the North Shore and Cape Ann, Inc.</u> works with persons of all ages and disabilities. They provide information and referral, advocacy, monthly support groups and monthly application assistance. They will survey buildings for accessibility through their APAB program.

Ms. St. Pierre stated that <u>Cerebral Palsy of Eastern Massachusetts</u> has locations in Salem and Lynn and serves ten cities. North Shore Infant & Toddler Program is an early intervention program for birth to age 3 with disabilities or developmental delays. The evaluation is at no cost to the family. They have weekly toddler groups for all children for socialization. She can come to agencies to talk to staff.

Ms. Winkler stated that she is new to the <u>North Shore CDC</u>. They are an affordable housing agency. They also offer ESL classes in Salem. She will work toward getting community engagement in the Point area of Salem and Gloucester Crossing.

Ms. Westley stated that she is the new Americore Vista at the <u>Children's Law Center</u>. The CLC represents children in certain court cases. They have an intake line. They provide training on various topics at organizations, such as rights for children. She provides community outreach.

Ms. Guy of the <u>City of Salem</u> Department of Planning & Community Development stated that the Consolidated Annual Performance and Evaluation Report will be available next week for a 15 day comment period. She reminded the group to forward event notices, job openings, etc. to her and she will either forward them on to the Salem HOPE email distribution list or include it in an upcoming newsletter.

Important MassHealth Application Update: "Visitor" Vs. "Residency" Question

In late October, the question on both the paper and Virtual Gateway MassHealth applications that asked if the applicant was "visiting" Massachusetts was CHANGED to ask whether the applicant is "living" in Massachusetts. While both the old and new questions are Yes/No questions, the OLD question asked about VISITING the state, while the NEW question asks about LIVING in Massachusetts.

OLD QUESTION – "VISITING"

Is this person <u>visiting Massachusetts</u> from another US state, US Territory or foreign country? Yes/No

The answer was NO if the person was residing in and not visiting MA.

NEW QUESTION - "RESIDENCY"

"Is this person who is applying for benefits <u>living in Massachusetts</u> <u>with the intention to stay?</u>

Do not include infants born in Massachusetts who have not left the state."

Yes/No

The answer is YES if the person is residing in and not visiting Massachusetts.

** IMPORTANT REMINDER: **

Please note the difference between the old and new questions as they each ask something DIFFERENT. As you go through the application, please read this (and every) question CAREFULLY. Your work has a direct impact on facilitating – or delaying - the submission and processing of applications.
