North Shore Elder Services Hosted December Meeting

The December, 2016 Salem HOPE meeting was hosted by the [North Shore Elder Services](#). Representing the agency were Director Paul Lanzikos, Kathy Perrella, Lisa Orgettas and Carolyn Lewis. Present were Jane Guy and Naomi Francisco of the City of Salem DPCD; Kim Rosenberg and Joyce Arcisz of Morgan Memorial Goodwill, Maureen Fiore of Aspire Developmental Services, Inc; Katina Polemenako of Salvation Army, Deborah Barber of the Independent Living Center of the North Shore and Cape Ann, Inc. (ILCNSCA), Matthew Castiglione of Deaf, Inc., Lee Hartmann of NSCAP, Christin Brown of Children's Friend & Family,

Stephan Jackson of Massachusetts Rehabilitation Commission (MRC), Anne-Marie D'Angelo-Florent of MassHealth, Carol Menton of Massachusetts Commission for the Deaf & Hard of Hearing (MDDHH), Richard Jache of Triangle, Inc., and Phil Hayes of Adult Foster Care of the North Shore.

Mr. Lanzikos welcomed the group and showed a brief video on the mission of North Shore Elder Services (NSES) and their scope of work. He stated that they focus on the needs of lower income, frail elders but have a broader mandate of services, such as families of all incomes. They provide homemaker services and home delivered meals. He stated that they are pleased to be working with Mayor Driscoll on the Age-Friendly Salem initiative. He stated that the conference room is available to groups for presentations and trainings and noted that Greater North Shore Link, a national effort to bring together services, has their bi-monthly meetings there. He added that client efforts are supported by their colleagues at Northeast ARC, which runs Shine Jewelry, where clients make and sell jewelry and have pop-up sales before various holidays.

Ms. Fiore stated that [Aspire Developmental Services](#) provides early intervention for ages 0-3, a pre-school program in Lynn and developmental services for persons with disabilities.

Ms. Rosenberg stated that [Morgan Memorial Goodwill Industries](#) is looking two job site specialists, full time at the Salem office.

Ms. Jackson stated [MRC](#) has three full time openings for vocational rehabilitation counsellors.

Ms. Perrella stated that NSES runs a family care-giver program, as well as three support groups regarding dementia/Alzheimer's.

Ms. D'Angelo-Florent stated that she is a member education rep for [MassHealth](#), providing education on enrollment and eligibility. She stated that she can provide presentations at agencies upon request.

Ms. Lewis stated that she is a care and life advocate for NSES, providing outreach to support groups. NSES is running a support group for those 50+ who have experienced abuse, neglect or exploitation.

Ms. Barber stated that [ILCNSCA](#) has two full time positions open listed on their website.

Mr. Jache stated that he is the site manager at Triangle, Inc., which is a day program for adults with disabilities.

Ms. Polemenako stated that the [Salvation Army's](#) provides a food pantry and emergency services.

Mr. Hayes stated that [Adult Foster Care of the North Shore](#) assists families who have members with disabilities to get financial assistance.

Ms. Brown stated that [Children's Friend & Family Services](#) will be merging with the Justice Resource Institute in January. They will be the northeast branch, but will keep their current name. The agency provides therapy in-office and at home.

Ms. Orgettas, stated that she works with community services at NSES, such as their bill payer and rep payee program.

Ms. Francisco stated that she administers the [housing programs for the City of Salem](#), such as First Time Homebuyer Program and the Housing Rehabilitation Loan Program, which can include handicapped access. The City is also a service agency for the State's Get the Lead Out Program.

Ms. Hartmann stated that [NSCAP](#) provides a fuel assistance program and that households can qualify even if heat is included in the rent. They are doing a community needs assessment this year.

Ms. Menton stated that she is a Case Manager for the [Commission for the Deaf & Hard of Hearing](#) and note that one person in five aged 12+ has hearing loss. They provide in service training, case consultation and accessibility services for any kind of hearing condition.

Mr. Castiglione stated that he is the Regional Director for independent training services in the Salem offices of [Deaf, Inc.](#) Their focus is on persons who are deaf, deaf/blind, late deafened and hard of hearing. Services include communication access. They connect clients with services. Their 40th anniversary is in 2017.

Ms. Polemenako stated that [Salvation Army](#) has a good neighbor fund for persons who are over-income and in need of fuel assistance and utilities.

Ms. Guy stated that the CDBG Action Plan process will start in January, 2017 with a public hearing. She also stated that [Root NS, Inc.](#) has opened in Shetland Park and that the non-profit offers employment training and job placement in the food service industry to at-risk youth between 16-24.

What is Salem H.O.P.E.?

Salem H.O.P.E. is a networking group of human service agencies that provide programs and services to Salem residents. It is a free forum for agencies to learn about the services being provided by other agencies in order to fill in gaps, coordinate efforts and avoid the duplication of services. All human service agency representatives are welcome to attend the quarterly breakfast meetings held at rotating locations.

If you are a Salem HOPE participant and require reasonable accommodation at a quarterly Salem HOPE meeting, please contact the meeting host location and make your request as soon as possible, but no later than close of day on the Monday prior to the meeting.

Salem HOPE hosts information on reasonable accommodation

Once you have committed to hosting a Salem HOPE meeting, you are encouraged to contact Massachusetts Commission for the Deaf & Hard of Hearing to request an American Sign Language (ASL) Interpreter at least two weeks prior to the meeting date. If you do not get any requests for ASL interpreters by close of day on the Monday prior to the meeting, you can cancel the request by 9:00am on the Tuesday prior to the meeting.

Need Energy Assistance?



The Massachusetts Good Neighbor Energy Fund is available to any Massachusetts household who, because of temporary financial difficulty, cannot meet a month's energy expense and is not eligible for state or federal energy assistance. Last year, the Fund helped thousands of individuals pay an energy bill.

To qualify for assistance from the Fund, an applicant's gross household income must fall between 60 and 80 percent of the state's median income levels. For example, a household size of 4 would need to have a gross yearly income of between \$66,387 and \$87,183 to qualify. The 2016-2017 campaign year's Fund disbursement is \$425 per eligible household per heating season.
