② Discussion on the Early Voting remote locations and dates + times were discussed as well as City Hall have

Bd of Registrar Donald Bates made a motion to approve Early Voting Locations, dates + times 2nd by Alex Mitchell. Motion voted 2-0 matter carries

③ Copy of Press Release was distributed

Bd of Registrar amended to include language about the New Poll Pads being introduced for the first time + to add language to use our website to find out about any upcomg voter registration drives 2nd -

Press Release adopted as amended by City Clerk

④ Roles + Responsibilities of Board - document was distributed referred to page 7 of booklet relative to registration functions + sessions. Donald Bates felt that the board should not be involved on election day (just as observers) in case of recounts, the board was willing to do voter registration session + voter education sessions in the future.

More discussion regarding robo calls for last day to register took place as well as a small discussion about census forms

⑤ Availability of bi-lingual translators for each polling location, every election City Clerk, True Simons, went through the list of each location for September and all but one precinct had coverage all day the one who coverage had a translator for ½ the day

Bd of Registrar Donald Bates stated it's been difficult in the past to get enough translators to cover all the locations and sometimes they don't show up or come back the next election - recognizes this is still a problem. Looks for organization to continue to help
