## Projects Outside of the Urban Renewal Area

- 266 Canal Street: Design Review for Entrance Corridor Overlay District Redevelop the property by removing all existing buildings and infrastructure and constructing five new buildings for a total of approximately 73,615 square feet with 250 residential units (of which 20% will be affordable), commercial space along Canal Street, and preservation of nine acres of open space. The project also includes construction of 117 surface parking spaces, 196 garage parking spaces, and supporting infrastructure. Continued from 3/22/23.
