In the event that we are unable to do so on matters not requiring a public hearing, we will post on the City of Salem's website an audio or video recording, transcript, or other comprehensive record of proceedings as soon as possible after the meeting.

Please make sure to remember to turn your microphone on and unmute yourself before raising your hand. Those participating by dialing in from their phones may also utilize the “Raise Hand” feature of this platform by pressing “*9” on your keypad.
