Ana Nuncio called the meeting to order at 8:38 a.m.

Ms. Nuncio requested a motion to accept the minutes from the February 27, 2020 meeting. Mr. Cruz motioned and Ms. Nuncio seconded. Vote by Rollcall:

At this time, Dr. Conrad informed the Committee the policy on field trips need to reviewed. Ana Nuncio inquired about the Transportation Policy. She asked if newcomers have been able

to get on the bus. She explained she wants a new bus for these students. She also asked if there was money in the budget to do this? Superintendent Smith informed her it is not budgeted but this is not an issue. Ms. Manning stated that Kristin Shaver told the committee newcomers were able to get on an existing bus this year. Mary had concerns about not having enough room on the bus next year.

The Committee held a brief discussion on who was eligible to ride the bus. Ms. Manning would like the policy to mirror what the district does with the homeless population. Dr. Conrad expressed concern about those who live within a mile of the school and adding this to our current policy. Mr. Cruz clarified that this policy would be covered through the budget to allow for newcomers enrolling after November 1. Mr. Cruz stated the issue of within a mile is a separate discussion. He also feels the current budget will accomplish what Mary is looking to do. There was discussion about who is eligible to ride under a mile from school.

At this time, the Committee voted to move policy number 5215.01 Directory Information Regarding Students to the full committee for a first reading. Mr. Cruz motioned to approve, and Ms. Nuncio seconded. Motion carried by roll call:

# PUBLIC PARTICIPATION AT SCHOOL COMMITTEE MEETINGS/PUBLIC HEARINGS

6409

It is the policy of the School Committee that the agenda shall include a provision for community and staff to address the School Committee on topics or issues that would be reflective of the public interest, but for a period of no longer than a 5 minute duration.

State law provides that all committee meetings shall be open to the public and to the press unless the committee shall vote to go into executive session. Further:

No person shall address a public meeting of a public body without permission of the chair, and all persons shall, at the request of the chair, be silent. No person shall disrupt the proceedings of a meeting of a public body. If after clear warning from the Chair, a person continues to disrupt the proceedings, the Chair may order the person to withdraw from the meeting and if the person does not withdraw, the Chair may authorize a constable or other officer to remove the person from the meeting.
