

Good morning Ilene,

Please find below the comments we have for all the petitions we received last week. Note that we have some major concerns with these two petitions which are identified in red below.

• National Grid @ Norman Street: The contractor must submit a street opening permit application to Engineering prior to performing the work. This application must be submitted a minimum of 7 days prior to the propose start of work date. All vaults and other structures to be installed within public right of way shall be AASHTO H20 rated. Contractor will need to replace full concrete panels after work is complete. Scoring pattern of concrete should match existing concrete sidewalk.

If the proposed excavation falls within the newly paved section of Norman Street, no openings will be allowed during first full year (until spring 2023). A hardship letter may be required to allow the work. The contractor will be responsible to restore the roadway surfaces following the City's special paving conditions, which will be included in the issued permit, and are outlined below:

- Temporary trench patch shall match existing Pavement Thickness (see attached detail D-1).
- Trench shall be allowed to settle for 90 days.
- After 90 days, complete 2" pavement mill and overlay curb to curb
- Reinstate brick sidewalks and base in kind; full concrete panel shall be replaced

Jay emailed Sibhita and Bob Coulter, curious what the purpose is for the new duct bank? Concerns with traffic management. Holyoke can be used as a quick detour around but it is heavily traveled and the neighborhood had to deal with construction all last summer and fall. Depending on the schedule of this work, could also conflict with detours at the Essex Street project.

• National Grid @ Peabody Street: The contractor must submit a street opening permit application to Engineering prior to performing the work. This application must be submitted a minimum of 7 days prior to the propose start of work date. All vaults and other structures to be installed within public right of way shall be AASHTO H20 rated. Contractor will need to replace full concrete panels after work is complete. Scoring pattern of concrete should match existing concrete sidewalk.

This duct bank on Peabody should be coordinated with the raised crosswalk being proposed in front of the development which will have new catch basins in gutter line. The proposed conduit would be in conflict with the proposed catch basin. This petition should be held until the Engineering has the opportunity to coordinate with National Grid the best location for their proposed conduit.

Dear Honorable Mayor Driscoll:

This request is for a Council Order to provide \$250,000 in funding to implement traffic calming measures along various city streets. Approval of these funds would allow the City to install sixteen asphalt speed humps on four streets within North Salem (Bufforn Street, Barr Street, Barntow Street, and Dunlap Street) as well as purchase and install temporary speed humps and speed custions along Columbus Avenue (Bayvisw Ave to Fort Awe), Federal Street (North St to Boston St), Mail Street (N. Washington Sq to Bridge St) and Proctor Street (Mansell Pkwy to Highland Ave).

Since launching the Traffic Calming Program in 2018, the Traffic & Parking Department has received over 30 requests and have been able to implement traffic calming projects at over 15 streets and/or intersections throughout the city. In most cases, the interventions resulted in reduced travel speeds and perceived improvements in safety from the neighborhoods who requested them. For example, in the North Salem neighborhood, the data shows that on Dunlap Street the percentage of vehicles driving over the speed limit decreased significantly from 56% to 11%. It is also important to note that the average daily vehicle volume on Dunlap Street remained nearly the same with 851 vehicles pre-installation and 805 vehicles while the temporary speed humps were in place.

In addition to these locations, the Department will continue to evaluate other requests and will be seeking funds in the FY23 budget to hire consultants, prepare design plans and purchase materials to continue piloting traffic calming measures as well as making some of these measures permanent. Our Department is also working in conjunction with the Planning and Engineering Departments to implement permanent safety improvements to the Point neighborhood along Congress St as part of \$3.25 million MassWorks Grant. Traffic Calming Program Overview

The City of Salem's Neighborhood Traffic Calming Program was established in 2018. The goal of the program is to implement small-scale, semi-permanent measures in order to reduce vehicle speeds and enhance safety for all roadway users including motorists, pedestrians, cyclists, etc. Less costly materials such as temporary speed humps, flex posts, signage and roadway striping can be utilized to test their effectiveness before determining whether to proceed with more expensive and permanent infrastructure upgrades.

Proponent(s) are asked to submit an application along with a petition from the neighborhood. This assists City staff with the intake of these requests and gives a sense of the magnitude of the issue(s) being raised. Once a request is received, Traffic & Parking Department staff work with the Police Department to collect traffic volume and speed data. Staff also review any crash data that may be available over a five-year period as well as conduct a "street diagnostic". This involves identifying all of the traffic ordinances that have been adopted by City Council on a particular roadway or intersection and comparing it to any existing signage. In addition, staff check with the Engineering Department to see if any road or sidewalk work is planned for the area including any utility installations or upgrades.

To further assist with the evaluation of each request, City staff have created a priority tool, utilizing Geographic Information System (GIS), which is a data mapping software system. The tool is split into four different criteria which considers surrounding demographics, land uses, crash history, and the speed and volume data collected by the Police Department. Visit https://traffic-calming-1-salemma.hub.arcgis.com/ to explore the prioritization tool.

Evaluating the results of the priority tool along with the other gathered information assists with determining whether traffic calming measures are deemed necessary and how soon resources can be allocated. Traffic calming is an iterative process and not a "one-size fits all" method, which may involve the use of different interventions to address an identified issue on a given street or intersection. City staff work to apply a context sensitive approach that considers pedestrian/cyclist activity, density of development, adjacent land uses as well as overall traffic flow when developing recommendations.

Once measures are implemented, staff collect additional data and observe the location to determine how effective the measures are or if other interventions need to be applied. Since launching the program in 2018, the Traffic & Parking Department has received over 30 requests and have been able to implement traffic calming projects at over 15 streets and/or intersections throughout the city. In most cases, the

interventions resulted in reduced travel speeds and perceived improvements in safety from the neighborhoods who requested them.

For example, in the North Salem neighborhood, speed humps and 20 mph speed limit signs were installed on Buffum, Barr, Barstow, and Dunlap Streets. The data shows that on Dunlap Street, the highest-recorded vehicle speed dropped from 65 mph to 48 mph, the average speed dropped from 26 mph to 20 mph, and the percent of vehicles driving over the speed limit decreased from 56% to 11%. It is also important to note that the average daily vehicle volume on Dunlap Street remained nearly the same with 851 vehicles pre-installation and 805 vehicles while the elements were in place.

Due to the success of the temporary installations at these locations, the Traffic & Parking Department is working to construct permanent speed humps in North Salem, which will be in place year-round. During this coming season, we will be re-installing speed humps along Chestnut Street, installing speed cushions on Valley Street, and are in the process of evaluating the effectiveness of materials placed on Cedar, Fairfield, and Gardner Streets from this past year. In addition, staff are working with on-call consultants to develop design plans with the goal of implementing measures this calendar year along the following roadways: Columbus Avenue, Federal Street, Mall Street, N. Washington Square, Proctor Street and the intersection of Franklin Street/Moulton Avenue/Orchard Street/Osborne Street.

Evaluating traffic calming requests may result in staff recommending the need for further study and analysis. In these instances, consultants are hired to perform traffic studies which involve a more in-depth assessment of traffic patterns, speeds as well as pedestrian and bicycle activity. Currently the Department is working with a consultant to evaluate the intersections of Tremont Street/Grove Street and Tremont Street/School Street and have engaged another traffic engineering firm to begin putting a scope together focusing on Broad Street including the intersections with Dalton Parkway/Flint Street and Winthrop Street. There are also times when survey work is needed to begin the process of developing more detailed design plans to address identified safety and accessibility issues. The Traffic & Parking Department is working in conjunction with the Engineering Department on several intersections throughout the city with the goal of constructing safer and ADA compliant crosswalks and sidewalks.

We are requesting an allocation of \$90,000 in Short-Term Capital for the purpose of hiring an interdisciplinary team to develop a strategy and plan for the provision of downtown Salem's future public parking infrastructure and any associated development opportunities over the midto long-term.

The plan will serve as a key resource, a 'road map', for decision-making regarding changes to the parking system, redevelopment opportunities, and financing approach. Because of the long-term nature, the analysis needs to consider the eventual replacement of existing structured public parking (e.g., Museum Place and South Harbor Garages) as well as a possible paradigm shift in parking demands that takes into account advancements in vehicle technology as well as the introduction and expansion of other mobility options. The scope involves analyzing several sites for possible parking structures and will include an analysis of which sites are most cost effective for new parking configuration could improve circulation and will identify which sites are likely to best lend themselves to development in addition to parking. A preliminary list of potential sites includes the Universal Steel Lot at 297 Bridge Street, Riley Plaza at 212 Washington Street, Klop Alley/Front Street, and Church Street – East and West surface lots. An expanded conceptual development study of the Klop Alley/Front Street lot is also needed and could be a second phase of this project if appropriate. Near-term recommendations on potential regulatory and operational changes are also to be included.

Staff in the Department of Planning and Community Development ('DPCD') and the Traffic and Parking Department ('TPD') have worked collaboratively to define a project scope that, when undertaken by the interdisciplinary team, will result in a comprehensive document that both

departments can use to guide future development projects to meet the city's parking goals and needs.

DPCD's preliminary conversations with traffic consultants have resulted in an estimated cost of \$90,000. This estimate accounts for the need for a truly interdisciplinary team that can examine not only the physical characteristics of subject properties and their suitability for structured parking, but also the economic feasibility of various structured parking and mixed-use scenarios for each of the sites.

Dear Mayor Driscoll:

Due to a continued vacancy in the Deputy Director of Finance position since March, the Finance Department has required temporary contracted assistance to meet the department's ongoing responsibilities. At the end of FY2021, the Finance Department contracted with accounting firm Clifton Larsen Allen (CLA) to provide temporary assistance in fulfilling the role of Deputy Finance Director. Additionally, when the Finance department experienced turnover in its Senior Accountant/Budget Analyst role, CLA provided temporary assistance for that role, and is currently providing training to the employee who was subsequently promoted to that role.

At the time the city's FY2022 budget was finalized, the Finance Department did not expect it would need continued temporary assistance well into FY2022. Unfortunately, due to a lack of experienced, qualified candidates for the Deputy Director of Finance position (and with many similar vacancies throughout municipal government in Massachusetts), to date, the city has been unable to hire to fill that role, necessitating the continued services from CLA. The Finance Department is currently projecting over \$40,000 in savings in its Full-Time Salaries line due to the above-mentioned vacancies. This request would transfer \$40,000 from the Full-Time Salaries line to the department's Contracted Services line for the costs associated with continued services from CLA for FY2022.



That a petition to the General Court, accompanied by a bill for authorization to enact a local condominium conversion ordinance for the purposes of tenant stability and maintaining the general welfare of Salem residents, as set forth below, be filed with an attested copy of this Order be, and hereby is approved to the end that the following legislation be adopted, except for amendments by the Senate or House of Representatives which conform to the intent of this home rule petition:

AN ACT authorizing the City of Salem to enact a condominium conversion ordinance for buildings containing two or more residential units.

Be it enacted by the Senate and House of Representatives in General Court Assembled, and by the authority of the same as follows:

AN ACT RELATIVE TO A CONDOMINIMUM CONVERSION ORDINANCE IN THE CITY OF SALEM.

SECTION 1. Notwithstanding the provisions of any general or special law to the contrary, the City of Salem City Council by majority vote may enact an ordinance to regulate the conversion of housing accommodations in the municipality to the condominium or cooperative form or ownership in buildings containing two or more residential units.

SECTION 2. Such ordinance may include, but is not limited to: (i) provisions for investigations and hearings on condominium conversions or proposed conversions; (ii) a permit process; (iii) tenant notification requirements; (iv) relocation costs for tenants and other measures to protect tenants; (v) control of evictions; (vi) penalties for violation of the ordinance; and (vii) afford tenants and the City or the City's Designee the right to purchase the residential property in which the tenant(s) reside(s) when the residential property is being offered for sale.

SECTION 3. The ordinance may establish a condominium review board or vest administrative duties in an existing municipal board, commission, or office. The review board may exercise such powers as it is given by the ordinance.

SECTION 6. This act shall take effect upon its passage.

Ladies and Gentlemen of the City Council:

In 1983 the Massachusetts Legislature adopted a condominium conversion law in response to a surge of conversions. The law allows for municipalities to adopt condominium conversion ordinances to prevent displacement by providing protections for tenants that reside in buildings with four or more units. For example, the ordinance can require landlords that convert their rental units into condominiums to provide their tenants with notification and assistance with relocation costs.

For municipalities to adopt a condo conversion ordinance, local legislative action must be accompanied by a declaration in the form of findings where local conditions constitute an acute rental housing emergency requiring local action.

The City, through our Affordable Housing Trust Fund Board and the work of our Department of Planning and Community Development, has studied the conversion rates in Salem and has found that the pace of condominium conversions in our community has steadily increased over the past six years while housing costs continues to rise. In this analysis, we found that 78% of apartments converted since 2016 are two- or three-family homes. Salem is rapidly losing its two- and three-family housing stock to conversions and therefore there is an acute need to protect tenants in building with two or more units.

The 1983 state law, however, only allows communities to provide tenant protection to tenants in buildings with four or more housing units. Absent a special act of the legislature, local action cannot lower this threshold. To that end, the proposed home rule petition would enable Salem to adopt a condominium conversion and tenant protection Ordinance that offers protections to Salem residents in buildings with two or more units.

The home rule petition also proposes a right of first refusal for tenants to purchase their converted units at market rate, and a second right of refusal for the City or a nonprofit to purchase the unit at market rate and to establish the unit as permanently affordable.

The full condominium conversion and tenant protection Ordinance will be filed with the City Council upon the successful adoption by the state legislature of the special act called for in this petition.

An Ordinance to amend Chapter 20, Fire Prevention and Protection relative to outdoor fireplaces

Be it ordained by the City Council of the City of Salem, as follows:

Section I. Amend Sec. 20-128. Sale of solid fuel outdoor patio and space heaters, outdoor decorative heating appliances, and outdoor fireplaces within the city by deleting paragraphs (a), (b) and (c) in their entirety and replacing them with the following:

"Any mercantile establishment located within the city shall be able to sell, or offer for sale, any outdoor patio or space heater or decorative heating appliance such as chiminea, fire pit, or outdoor fireplace that is fueled by a solid fuel such as wood, charcoal, fuel pellets or similar non-gaseous fuels."

Section II. Amend Sec. 20-129. Use of solid fuel outdoor patio and space heaters, outdoor decorative heating appliances and outdoor fireplaces within the city by deleting paragraph (a) in its entirety and replacing it with the following:

- "(a) Definitions. The following definitions shall be used in this Chapter:
 - Attended. Under the personal supervision of an adult over the age of 21 who shall remain at the location of the fire until the fire is thoroughly extinguished.

Chiminea. Portable devices, as defined by the manufacturer, intended to contain and control outdoor fires and which emit smoke or products of combustion from an enclosed chamber through a stack, chimney, duct, flue or pipe.

Fire pit. Portable devices, as defined by the manufacturer, intended to contain and control outdoor fires; permanently or temporarily constructed above-ground and below ground pits intended to contain and control outdoor fires.

Nuisance. Any odor, emission, or event that prevents the reasonable use and enjoyment of one's property.

Outdoor burning device. Any chiminea, fire pit, outdoor fireplace as defined in this section.

Outdoor fireplace. Portable devices, as defined by the manufacturer, intended to contain and control outdoor fires which may be open in design or which emit smoke or products of combustion from an enclosed chamber through a stack, chimney, duct, flue or pipe; permanently constructed devices intended to contain and control outdoor fires which may be open in design or which emit smoke or products of combustion from an enclosed chamber through a stack, chimney, duct, flue or pipe.

- (b) Use of fire pit. The primary purpose of the fire must be for cooking unless a burning permit is obtained from the city fire department and all relevant conditions of such permit are adhered to. Cooking fires must be reasonable in size. Use must also comply with general requirements for all outdoor burning devices as stated in subsection (e) of this section.
- (c) Use of chiminea. The primary purpose of the fire need not be for cooking and a burning permit is not required. Use must also comply with general requirements for all outdoor burning devices as stated in subsection (e) of this section.
- (d) Use of outdoor fireplace. Unless the outdoor fireplace emits smoke or products of combustion from an enclosed chamber through a stack, chimney, flue or pipe, the primary purpose of the fire must be for cooking unless a burning permit is obtained from the city fire department and all relevant conditions of such permit are adhered to. Cooking fires must be reasonable in size. If the outdoor fireplace emits smoke or products of combustion from an enclosed chamber through a stack, chimney, duct, flue or pipe the primary purpose of the fire need not be for cooking and a burning permit is not required. Use must also comply with general requirements for all outdoor burning devices as stated in subsection (e) of this section.
- (e) General requirements for all outdoor burning devices. All use of outdoor burning devices must be attended, conducted during periods of good atmospheric ventilation and without causing a nuisance. If the city fire department receives a complaint that the smoke or product of combustion emitted from an outdoor burning device is causing a nuisance, the fire department will investigate and if necessary, have the fire extinguished.

The outdoor burning device may only be upon a flat surface of sandy or gravelly land or otherwise non-combustible material free from living or dead vegetation. Any permanently constructed outdoor burning device may be constructed using only non-combustible materials.

Safety Measures shall be put in place at all times, either a hose or fire extinguisher shall be accessible at all times.

The outdoor burning device shall not be located within 25 feet of any structure and shall not be used on decks and porches or 15 feet away from a property line or fence.

For those outdoor burning devices in which wood is burned, only the burning of aged. dried wood is permitted

Burning of grass, hay, leaves, stumps and tires is prohibited. The burning of any type of construction material or trash is prohibited."





An Ordinance to amend an ordinance relative to municipal buildings, operations and transportation

Section 1. Chapter 12 Building, Electricity and Plumbing Regulations is hereby amended by adding the following new Article:

"ARTICLE V. GREENING THE CITY OF SALEM'S MUNICIPAL BUILDINGS, OPERATIONS AND TRANSPORTATION

SEC. 12.250 PURPOSE

The purpose of this Ordinance is to promote public health, safety, and welfare by requiring sustainable design, construction, purchasing and practices for municipal buildings, operations, and transportation. This Ordinance intends to promote energy conservation, improve environmental quality and encourage Low Impact Development (LID) principles.

Through this Ordinance, the City of Salem intends to lead by example in setting standards for its own buildings, operations and transportation; reduce its greenhouse gas emissions by reducing energy consumption, shifting to renewable sources of energy and embracing smart, clean technology; strive to reduce, reuse and recycle products to decrease pollution and minimize impacts on our community and natural resources; and shift its transportation fleet to electric and hybrid vehicles while easing options for electric vehicle car charging and bicycle parking.

The City of Salem is committed to fulfilling a 100% zero net energy goal by maximizing onsite renewable energy production while minimizing energy consumption and the operational costs of municipal buildings.

SEC. 12.251 GREEN MUNICIPAL BUILDINGS

(1) NEW CONSTRUCTION, RENOVATION, AND ADDITIONS

City-owned or leased new construction or major renovations greater than or equal to five thousand square feet (5,000 sq. ft.) and City-owned or leased major renovations greater than or equal to ten thousand square feet (10,000 sq. ft.) to a current structure shall be certified as, at minimum, one of the following:

- Passive House Institute US (PHIUS) PassiveHouse®
- United States Green Building Council (USGBC) LEED® Gold
- Another applicable sustainable rating system as approved by the Mayor with the recommendation of the Sustainability, Energy, and Resiliency Committee.

In addition to the requirements set forth above, all new City owned or leased buildings and major renovations under 5,000 sq. ft. must incorporate sustainable building practices, as applicable, including, but not limited to:

- All projects must be designed and installed to maximize utility incentives
- All projects shall consider the repurposing, reuse, or recycling of building materials to the extent
 feasible. In addition to the requirement set forth above, all new City-owned or leased buildings, major
 renovations of City-owned or leased buildings or complete roof replacements on City-owned or leased
 buildings must include at least one of the following:
 - Solar power system
 - Green Roof
 - White Roof/Solar Ready

(2) DESIGN TEAMS

All requests for design services for City owned or leased facilities shall reference this Ordinance.

For those projects before the Designer Selection Committee, the Committee shall ensure that design teams selected for all applicable projects that are subject to this Ordinance shall be qualified to implement the standards in this ordinance and, at a minimum, include one LEED® accredited professional, or other comparable accreditation with demonstrated experience in designing buildings that would meet the requirements of this Ordinance.

(3) GREEN INFRASTRUCTURE AND PERMEABLE MATERIALS

City-owned properties shall employ best management practices and Low Impact Development (LID) to minimize stormwater runoff, thereby keeping water sources cleaner and reducing flooding. Additionally, land management practices shall maximize or increase sustainable vegetation to mitigate urban heat island effects and reduce flooding and encourage stormwater infiltration.

All City projects must meet the federal requirements for stormwater regulations if the new paved area is over five thousand (5,000) square feet and for any size projects requiring impervious surface it is encouraged to utilize permeable materials, including but not limited to porous paving, concrete, and bricks, when appropriate.

(4) MAINTENANCE AND TRAINING

All new and major renovations projects must include an operation and maintenance plan which includes training. Ongoing training related to the provisions of this Ordinance shall be considered by Departments in their annual budget submissions.

SEC. 12.252 GREEN MUNICIPAL OPERATIONS

(1) ENVIRONMENTALLY PREFERABLE PURCHASING

The City of Salem's Purchasing Department shall create, withing three months of the date of this ordinance, an Environmentally Preferable Purchasing Program (EPPP) to guide the purchasing of sustainable products for city buildings, operations, and city-run events. The EPPP shall include standards for third-party certifiable green cleaning products; recycled and/or compostable plates, utensils, cups; hybrid or electric vehicles; low-emitting and recyclable materials; EnergyStar® appliances; and training for relevant City Departments and staff in procurement practices reflective of the EPPP. The EPPP shall be updated every two years at a minimum and submitted to the Sustainability, Resiliency, and Energy Committee for review and comment whenever so updated.

(2) WASTE REDUCTION

All occupied city-owned or leased buildings shall be equipped with recycling and composting bins to encourage and incentivize waste reduction. All parks or other City owned properties that have a waste receptacle shall also have a recycling bin. For projects involving site work or refurnishing, the City shall seek to restore, repurpose or recycle materials and furniture to the extent feasible and applicable.

SEC. 12.253 GREEN MUNICIPAL TRANSPORTATION

(1) CLEAN TRANSPORTATION ALTERNATIVES

The EPPP shall include standards for City-owned vehicles that shift the City's fleet to all electric and/or hybrid modes of transportation. Heavy duty vehicles and emergency vehicles shall also be transitioned to a higher efficiency and non-polluting fleet as technologically feasible. The City's municipal light-duty fleet shall be 100% zero-emissions by 2030, as technologically feasible, and the remaining fleet as technologically and financially available

(2) ELECTRIC VEHICLE CHARGING STATIONS

All new city-owned buildings and new or renovations of parking lots with more than 25 parking spaces shall include electrical vehicle charging stations to encourage use of lower-emission vehicular transportation.

(3) BICYCLE PARKING

All new construction and major renovations at city-owned buildings, parks, and other public properties shall include bicycle parking.

SEC. 12-254 APPROVALS AND WAIVERS

For all City projects subject to any provision of this Ordinance, the Purchasing Agent shall certify such compliance.

For projects between \$100,000 and \$999,999 seeking a waiver from any provision of this Ordinance, the Purchasing Agent, in consultation with applicable Departments, shall provide such waiver.

For projects over \$1,000,000 seeking a waiver from any provision of this Ordinance, the Department responsible for the project shall request a waiver from the Purchasing Agent who shall seek input and recommendation from the Sustainability, Energy, and Resiliency Committee (SERC).

The Purchasing Department shall document waivers requested and shall provide a report to SERC annually.

SEC. 12.255 DEFINITIONS

For the purpose of this Ordinance, unless the context requires otherwise, the following terms shall have the following meanings:

Addition: Any portion added to an existing building.

Best Management Practices (BMPs): Regarding stormwater, BMPs means schedules of activities, practices (and policies), structures, vegetation, maintenance procedures, and other management practices to prevent or reduce the discharge of pollutants to waters. BMPs also include the treatment requirements, operating procedures, and practices to control plant site runoff, spillage or leaks, sludge or waste disposal, or drainage from raw material storage.

Environmentally Preferable Purchasing Program: A plan to procure more environmentally friendly products.

LEED: The USGBC (United States Green Building Council) Leadership in Energy and Environmental Design Green Building Rating System®.

Light Duty and Heavy Duty Vehicles – Heavy duty vehicles are defined as those with a gross vehicle weight (GWV) of 8,500 pounds or more. A vehicle less than 8,500 GVW is considered a light duty vehicle.

LID: Low Impact Development, a land planning and engineering design approach to manage stormwater runoff as part of green infrastructure. LID emphasizes conservation and use of on-site natural features to protect water quality.

Passive House: A environmental building certification from PHIUS (Passive House Institute US).

Square Feet: The gross square footage being constructed or renovated as listed on the building permit. For parking project, the square footage is the amount of impervious surface used to calculate the stormwater regulations.

Sustainable Vegetation: Plantings and landscaping that include native species to the maximum extent possible and selected to survive with minimal resource inputs (fertilizers, watering, etc.) and management (mowing, weeding, etc.)."
