- A. No person shall park a vehicle other than a taxicab upon any street within a business district in any taxicab stand.
- B. No person shall park a taxicab upon any street within a business district at any place other than the taxicab stand or stands designated for the use of his taxicab or taxicabs, except while engaged or while waiting for an opportunity to use a taxicab stand designated for his use.

### 18. Reserved parking, Holyoke Square.

Parking shall be reserved in accordance with the Salem Redevelopment Authority Deed of Easement recorded at Book 22087, Page 438, which restricts parking exclusively for Holyoke Square, Inc. during regular business hours, defined as Monday through Friday, from 7:30 a.m. to 5:30 p.m., at 13 parking spaces along the Holyoke Square side of so much of the public ways known as Norman Street and Holyoke Square as about Holyoke's property at Holyoke Square.

A violation of this Ordinance shall be considered a violation of a restricted parking area. (Ord. of 2-10-2005)

## 19. Parking vehicles for sale prohibited.

M. and 8:00 A. M. and for any longer than one hour between the hours of 8:00 A. M. and 5:00 P. M., except for the purpose of receiving or discharging passengers, or for loading or unloading goods. Any vehicle not actually engaged in receiving or discharging passengers or loading or unloading goods shall be subject to the penalties provided by Chapter 90, Section 20C, and Chapter 40, Section 22D of the General Laws, and shall be liable to charges for the removal and storage of the vehicle. This subsection shall not apply to any standard size single rear wheel pick-up truck. (6/29/93)
- (c) Any person who violates any provision of this section shall be subject to a one hundred dollar (\$25.00) fine for first offence, two hundred doallar \*\$200.00) fine for second offense and three hundred dollar (\$300.00) fine for third,and for subsequent offenses, the vehicle may be towed. - (d) Vehicles owned by the Commonwealth or a political subdivision thereof or by the United States, as more fully described in Chapter 40, Section 22D of the General Laws, shall be exempted from the provisions of this Ordinance.
- (e) No commercial vehicles loaded with debris shall be allowed to park on any street in an "R" (residential) district within the city between the hours of 5:00 P. M. and 8:00 A. M. and for any longer than one hour between the hours of 8:00 A. M. and 5:00 P. M. except for the purpose of loading or unloading goods. Any vehicle not actually engaged in loading or unloading goods shall be subject to the penalties provided by Chapter 90, Section 20C, and Chapter 40, Section 22D of the General Laws, and shall be liable to charges for the removal and storage of the vehicle. (6/29/93)

- (f) Commercial vehicles parked directly in front of a legal "nonconforming" business, located in any "R" (residential) district within the City, shall be exempted from the provisions of this Ordinance. (12/31/86 DPW E5-258-2803)

### 22. Parking time limited; hours of operation.

(Formerly Chapter 42, Article V, Sec. 57.)

No person shall park a vehicle on the same street block for a period of time longer than four hours, or longer than such other period of time as may be hereafter specifically provided in certain parking meter zones, between the hours of 8:00 A.M. to 6:00 P.M. on any of the streets or parts of streets designated in section 56 hereof, or as may hereafter be established by ordinance on any day.

No person shall park a vehicle in a monthly zone without the appropriate monthly zone pass between the hours of 8:00 A.M. to 6:00 P.M. any day. This restriction shall not apply on Sundays or during the hours of legal holidays during which business establishments are required by law to remain closed. (7/14/11)

### 23. Acquisition and installation; space between meters.

(Formerly Chapter 42, Article V, Sec. 58.)

The Mayor is hereby empowered, with the approval of the City Council Traffic and Parking Commission, to contract, in accordance with the provisions of M.G.L.A C. 40, S.22A, for the acquisition and installation of parking meters provided for by this division and to maintain such meters in good workable condition.

The Traffic Committee Traffic and Parking Commission is hereby authorized and directed to install parking meters within the areas described in this division or cause the same to be so installed. The meters shall be placed at intervals of not less than 20 feet apart, except that at the beginning and ending the spaces may be 18 feet apart and except in the municipal parking area and where angle parking is permitted, and not less than 12 inches nor more than 24 inches from the face of the curb adjacent to individual meter spaces.

### 24. Meter signals indicating legal/illegal parking; overtime parking.

(Formerly Chapter 42, Article V, Sec. 59.)

Meters shall be so constructed as to display a signal showing legal parking upon the deposit therein of the proper coin or coins of the United States as indicated by instruction on such meters and for such period of time as is or shall be indicated by this division or subsequent ordinances. Such signal shall remain in evidence until expiration of the parking period designated at which time a dropping of a signal automatically or some other mechanical operation shall indicate expiration of such parking period. In such case any vehicle remaining parked in any parking meter space adjacent to such meter displaying a signal indicating the expiration of a parking period shall be considered as parking overtime in violation of this division and the operator, owner, or manager thereof shall be subject to the penalties provided in section 17 hereof.

### 25. Establishment and marking of spaces.

(Formerly Chapter 42, Article V, Sec. 60.)

The traffic committee Traffic and Parking Commission is hereby authorized and directed to establish or cause to be established parking meter spaces, in such parking meter zones, as are herein specified, or as may be hereafter fixed by ordinance, and to indicate the same by white markings upon the surface of the highway.

# 26. Bus stops, taxicab stands, service zones, etc.

(Formerly Chapter 42, Article V, Sec. 61.)

Nothing in this division shall be construed as prohibiting the city from providing for bus stops, service zones, truck stands and taxicab stands within metered zones.

# 27. Deposit of coins required to use parking spaces; unused time.

(Formerly Chapter 42, Article V, Sec. 62.)

Whenever any vehicle shall be parked adjacent to a parking meter, the owner or operator of such vehicle shall park within the space designated by street marking lines and upon entering such space shall immediately deposit in such meter the required coin of the United States for the maximum legal parking period or proportionate period thereof both as indicated or shown on the meter, and, if so required, set the mechanism in motion; provided, that any person placing a vehicle in a parking meter space adjacent to a meter which indicates that unused time has been left in the meter by the previous occupant of the space shall not be required to deposit a coin so long as his occupancy of such space does not exceed the indicated unused parking time.

### 28. Fees

(Formerly Chapter 42, Article V, Sec. 63.)

The fee for the maximum parking time in parking meter zones and in municipal off-street parking meter zones, as determined by the Salem Parking Board, shall not exceed \$0.75 per half hour. (6/1/98; 4/23/09; 7/14/11)

# 29. Deposit of coins to extend parking time beyond legal time.

(Formerly Chapter 42, Article V, Sec. 64.)

It shall be unlawful for any person to deposit or cause to be deposited in a parking meter any coin for the purpose of permitting the vehicle of which he is in charge to remain in a parking space beyond the maximum period of time allowed in a particular zone.

# 30. Vehicles to be parked wholly within designated spaces.

(Formerly Chapter 42, Article V, Sec. 65.)

It shall be unlawful for any person to park a vehicle within a parking meter space unless such vehicle is wholly within the painted lines adjacent to such meter.

## 31. Tampering with, depositing slugs, etc.

(Formerly Chapter 42, Article V, Sec. 66.)

It shall be unlawful for any unauthorized person to tamper with, break, injure or destroy any parking meter or to deposit or cause to be deposited in such meter any slugs, device or metallic substance or any other substitute for the coins required.

# 32. Commercial vehicles loading or unloading.

(Formerly Chapter 42, Article V, Sec. 67.)

Operators of commercial vehicles may park in a metered space without depositing a coin for a period not to exceed 30 minutes for purposes of loading or unloading. Parking in excess of this time limit without depositing the proper coin shall be deemed a violation of the provisions of this division.

## 33. Collection and deposit of money: City of Salem Parking Meter Account.

(Formerly Chapter 42, Article V, Sec. 68.)

The Police Department Traffic and Parking Department is hereby designated as the agency authorized to collect moneys deposited in parking meters or to cause the same to be so collected. Such moneys shall be deposited forthwith with the City Treasurer in a separate account to be known as the "City of Salem Parking Meter Account".

### 34. Use of fees received.

(Formerly Chapter 42, Article V, Sec. 69.)

All fees received by the city from the operation and use of parking meters shall be used and expended as authorized by Massachusetts General Laws, Chapter 40, Sections 22A and 22B.

#### 35. Enforcement of division.

(Formerly Chapter 42, Article V, Sec. 70.)

It shall be the duty of police officers to enforce the provisions of this division.

### **Article V-A. - TOW-AWAY ZONE REGULATIONS**

### 36. General prohibition towing zones.

(Formerly Chapter 42, Article V, Sec. 74.)

No person shall stand or park or allow, permit or suffer any vehicle registered in his name to stand or park in any of the following places. Vehicles found in violation of the provisions of this section, except these specifically exempt by law, shall be removed to a convenient place under the direction of an officer of the Police Department and the owner of a vehicle removed or towed away shall be liable to the cost of such removal and storage, if any vehicle removed or towed away under the provisions of this Section shall also be subject to the penalties provided in Chapter 90 Section 20A of the Massachusetts General Laws. (3/20/75 DPW B-45)

Upon any way in such a manner as to impede the removal of plowing of snow or ice, except vehicles parked in accordance with approved regulations governing All Night Parking. (3/20/75 DPW B-45)

Upon any sidewalk. (3/20/75 DPW B-45)

Upon any marked crosswalk. (3/20/75 DPW B-45)

# 37. Parking prohibitions towing zone (resident sticker)

(Formerly Chapter 42, Article V-A, Sec. 75.)

In order to reduce air pollution caused by fuel emissions and other environmental effects of automobile commuting, such as to reduce traffic hazards and highway congestion, noise and litter, thus encouraging

reliance on car pools and mass transportation, the City Council enacts the attached ordinance comprising the following zones:

### **ZONE A—BLUE**

Includes Ward 1 Precinct 1 Area is adjacent to Pickering Wharf and runs to the Salem Willows Amusement Park.

#### ZONE B-RED

Includes area in Ward 7 encompassing Salem State College Area. This area is affected by commuter traffic attending Salem State College. (11/1/93)

#### ZONE C-GREEN

Includes area adjacent to the central downtown business district and courthouse complex in Ward 2 and parts of Zone C in Ward 3.

#### ZONE D-YELLOW

Includes area adjacent to the central downtown business district.

#### ZONE E—ORANGE

Includes area in Ward 5 encompassing Salem State College Area. This area is affected by commuter traffic attending Salem State College. (11/1/93)

### ZONE F-WHITE

Includes areas in Ward 6.

No person shall stand or park or allow, permit or suffer any vehicle registered in his name to stand or park on any of the ways or parts of ways hereinafter described and during the periods of time set forth unless said vehicles bear a clearly visible resident parking sticker or visitor parking permit issued and displayed on said vehicles as hereinafter provided or unless said vehicles bear a handicapped license plate issued by the Registrar of Motor Vehicles pursuant to Massachusetts General Laws Chapter 90 Section 2. (4/13/87)

### Official Traffic Signs

The provisions of Section 75 shall be effective only during such time as sufficient number of official traffic signs bearing the legend "Tow-Away Zone" are installed, erected, maintained and located as to be visible to approaching drivers, said signs to be appended above or incorporated into the legend of Resident Parking Prohibition Signs.

### **Resident Parking Zones**

The following zones are hereby designated resident parking zones and only streets within these zones shall be eligible to be made limited to resident parking: ZONE A ZONE B ZONE C ZONE D ZONE E ZONE F (9/20/93 & 11/1/93)

The boundaries of the aforementioned zones are shown on a plan on file with the City Collector entitled "City of Salem Residential Parking Zones:

Parking Prohibitions Towing Zone (Resident Sticker) and is incorporated and made part of this ordinance. (9/20/93)

#### Procedures for Obtaining Stickers.

A. Eligibility: Any motor vehicle owned by a resident domiciliary of the City of Salem registered under the General Laws of the Commonwealth of Massachusetts registered and garaged in the City of Salem, excluding any vehicles prohibited from residential areas under the provisions of Chapter 42, Section 55B, shall be eligible for a Resident Parking Sticker provided said resident domiciliary resides in one of the zones aforementioned and streets hereinafter mentioned. A resident sticker parking permit applicant shall provide the City Collector with a vehicle registration, drivers license, and utility/household bill as proof of current residency. (9/30/93) (line 3-6/17/96) (2/5/09)

Eligibility of Salem State College Students Living Off Campus: A resident sticker parking permit shall be issued to a Salem State College student living off campus with proof of a residential lease and/or utility bill in the student's name for a residence in one of the zones aforementioned and street hereinafter mentioned, College issued enrollment verification and vehicle registration, regardless of where the vehicle is registered.

Compliance with state and local laws: No resident parking stickers shall be issued for any unit where the number of non-related residents violates the State Building Code and/or City Ordinances, as determined by the City's Building Inspector. (2/5/09)

B. How and where to obtain stickers: The City Collector of the City of Salem shall be in charge of issuing stickers to residents upon verification of residence, domicile and registration. The City's Police and Parking Department shall be responsible for enforcement of the ordinance. The Police Chief or his designee, or the City Collector, may alter the requirements for obtaining a resident sticker in limited circumstances, and upon consultation with the Ward Councilor. Renewal of resident sticker parking permits shall be on a rolling basis by zone and staggered throughout the year, as determined by the City Collector. (9-20-93) (11-27-00) (2/5/09)

The sticker is to be placed on the front window, driver's side, lower left corner.

- C. Visitor parking permits: The City Collector shall also be in charge of issuing two portable visitor Parking Permits per household excluding College Student Resident Parking Permit holders as defined in sub-section A above that shall be used for visitors of the residents of the area. Proof of residency is required as in Sub-Section B above. At the discretion of the City Collector, visitor parking permits may either be issued in hand or mailed to a resident parking permit holder. Visitor Permits will not be replaced if lost. The Visitor Permits are to be used ONLY while visitors are actually visiting the household to which the permits are issued. Visitor permits shall carry the address of the household to which they were issued, and shall be valid only within the immediate area of the address so stated on the permit, and for a period of time not longer than 14 consecutive days for any one visitor. Any abuse in the use of a Visitor Permit will result in the revocation of the Permit. The Visitor Permits are to be displayed on the front dashboard, above the steering wheel, and must be fully readable from the exterior of the vehicle. The Visitor Permits must be returned to the resident at the conclusion of the visit. (9/20/93) (2/5/09)
- D. **Fees:** The fee for each resident Parking Sticker shall be \$10.00 and shall be valid for a period of two years, provided that the owner of the vehicle continues to be domiciled within the zone indicated on the resident parking permit, in the event the owner of the vehicle is domiciled outside the zone indicated, the resident parking permit shall be considered null and void. The fee for each Visitor Parking Permit shall be \$1.00 and shall be valid for two years. (2/5/09)

Fees for Salem State College Students Living Off Campus with non-Salem vehicle registration: The fee for each Resident Parking Sticker issued to a Salem State College student living off campus and eligible for such a Permit shall be \$10.00 and shall be valid for a period of one year, provided that the owner of the vehicle continues to be domiciled within the zone indicated on the resident parking permit. In the event the owner of the vehicle is domiciled outside the zone indicated, the resident parking permit shall be considered null and void. No Visitor Parking Permits shall be issued. (2/5/09)

### E. Miscellaneous:

1. If a person looses or has his permit stolen, the City Collector must be notified immediately so as to enable the City Collector to notify the Police Department of Stolen or lost permits. (9/20/93) (2/5/09)

- 2. The City Collector shall keep records of the issuance of all resident stickers and permits and their expiration dates, and shall have authority to issue replacement stickers or permits at no cost in the event that they are lost or stolen, or upon proof of the sale or trade-in of a vehicle which had been issued a valid Resident Parking Sticker. (9/20/93) (2/5/09)
- 3. The City Collector is authorized to revoke the residential parking sticker of any person found in violation of these regulations and, upon written notification thereof, the person shall surrender the sticker and Visitor Permit (if issued) to the City Collector. If the person does not return the sticker and visitor permit to the City Collector as requested, the City Collector shall forward the vehicle registration number and vehicle I. D. number to the Police Department. (9/20/93) (2/5/09)

(Formerly Chapter 42, Article VII.)

# 38. Parking and traffic regulations on grounds of Salem High School.

(Formerly Chapter 42, Article VII, Sec. 87.)

The following parking and traffic regulations shall be in effect on all roads and ways, in existence on the grounds of the Salem High School, located at 77 Willson Street, Salem, Massachusetts.

No person shall park a vehicle on any of the roads and ways located on the grounds of the Salem High School.

The roads at the immediate front and rear of the Salem High School are hereby designated as fire lanes and can be used only in accordance with the other provisions of this Ordinance relative to fire lanes.

No person shall park a vehicle on said grounds of the Salem High School except on the student, faculty, and visitor parking lots.

Handicapped persons may park in the designated lot in front of the Unified Arts wing of the building.

No person shall operate a vehicle on any of said roads and ways above the limit of eight miles per hour.

The Police Department of the City of Salem shall enforce all provisions of this Ordinance as well as insuring compliance with posted parking, pedestrian and vehicular directions in order to eliminate hazardous conditions. (11/17/77 DPW B-3146)
