The City Council Committee on Administration and Finance Co-posted with the Committee of the Whole will meet remotely on Thursday, June 10, 2021 at 6:00 P.M. for the purpose of discussing Bond Order FY2022 General Fund CIP, Bond Order FY2022 Water / Sewer CIP, FY2022 Short Term CIP and adopting the FY2022 proposed 5 year Capital Plan 2022-2026.

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §20, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Committee on Administration and Finance co-posted with the Committee of the Whole will be conducted via remote participation to the greatest extent possible.
