The City Council Committee on Administration and Finance co-posted with Committee of the Whole will meet remotely on Thursday, July 2, 2020 at 6:00 P.M. for the purpose of discussing the Fiscal Year 2021 PEG Enterprise Fund.

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §20, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this committee meeting will be conducted via remote participation to the greatest extent possible.
