

## **NOTICE OF PUBLIC MEETING**

You are hereby notified that the Public Art Commission will be holding a meeting on Tuesday, July 19, 2022, 6:30 pm at the Community Life Center, Board Room, 401 Bridge Street, Salem, MA

#### **Important Announcement**

This meeting was posted prior to the anticipated expiration, Thursday, July 15th at midnight, of the pandemic-related Open Meeting Law relief. Although it was anticipated that the Governor would take action to resolve the current ambiguity in the application of the law and any further extensions, at this time no conclusion has been reached. This meeting, already posted in accordance with the provisions of the Open Meeting Law, will be held as scheduled to avoid interruption of vital government services the public has come to expect and to avoid excluding members of the public who planned to attend remotely.

Members of the public may attend in person or remotely via Zoom, per the directions below. Remote participation by members of the public for observing/listening to a meeting, or providing public comment, shall be maintained to the best ability of the Public Art Commission. Every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. If technological issues arise the meeting may still proceed in person at the discretion of the Chair.

Members of the public attending this meeting virtually will be allowed to make comments during the portion of the hearing designated for each agenda item. Members of the public will be asked to use the virtual "Raise Hand" function in Zoom to indicate that they would like to provide comment. Dial \*9 on your phone's dial pad to raise your hand if you are using the toll-free phone number. Click the "raise hand" button if you are using the Zoom application on your computer or phone.

Alternatively, members of the public can email their comments/questions to <u>ibarry@salem.com</u> a minimum of 2 hours before the start of the meeting to have them read into record during the meeting by City Staff.
