In accordance with Chapter 20 of the Acts of 2021, this meeting of the Salem Public Art Commission will be conducted via remote participation. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. #### **Remote Participation Instructions:**

#### **Public Comment Protocol:**

In order to raise a hand, members of the public using the Zoom computer or phone applications may click the "Raise Hand" feature that can be found next to your name on the participants screen to 'raise your hand' then wait to be called upon for comment. Please make sure to remember to turn your microphone on and unmute yourself before raising your hand. Those participating by dialing in from their phones my also utilize the "Raise Hand' feature of this platform by pressing "\*9" on your key pad.
