Salem School Committee Meeting Minutes Monday, November 4, 2019

A regular meeting of the Salem School Committee was held on Monday, November 4, 2019 at 7:00 p.m. in the School Committee Chambers at Collins Middle School, 29 Highland Avenue, Salem, MA.

Call of Meeting to Order

Mayor Driscoll called the regular meeting of the Salem School Committee to order at 7:00 p.m.

Public Comment #1: Questions and Comments from the Audience

Jamie Navins, SHS Math Teacher, 14 Andrew Street, shared concerns on the lack of instructional time at Salem High School and details of teacher block schedules. Ms. Navins shared her concerns on the loss of learning due to an all-school assembly fundraiser event that was held during instructional time. Ms. Navins expressed that these types of events should not be scheduled during instructional time as it causes loss of learning time. Ms. Navins urged the School Committee to please consider communicating them into the assembly during school days, given the limited amount of learning time that students have.

Superintendent's Report

Update on the 2020-21 Principal Hiring Process for Bentley and Salem High School

Superintendent Smith talked about a prepared timeline for the recruitment and hiring process of the Bentley Principal position and the Salem High School Principal position in the district. Superintendent Smith reported that an Innovation Planning Committee is underway to develop an innovation plan for the school. Should the teachers adopt the final plan, it would be forwarded to the School Committee for their review and approval later this year. The principal position for the Bentley school will be posted later this year, and a screening team of stakeholders will be formed. Superintendent Smith reported they would like to identify a consultant to lead the district through the Salem High School Principal search process to allow engagement of all stakeholders.

Other Presentations and Reports

Student School Committee Representative Report

Ms. Jillian Flynn, Student Representative and Senior at Salem High School, provided updates on the Student Advisory Council. Ms. Flynn announced that their meetings are open to anyone and encouraged 9-12 grade students in the district to take part at their meetings. The next meeting is scheduled for Wednesday, November 7, 2019 from 5-7pm at the Collins Middle School, in Room 130. Ms. Flynn shared a brief summary of some of the things that is happening at the high school.

Annual Innovation School Evaluations and Update on Salem's Innovation Schools: Carlton Innovation School and New Liberty Innovation School

Bethann Jellison, Principal of the Carlton Innovation School, and Jennifer Winsor, Principal of New Liberty Innovation School presented their annual school evaluations and provided an update on each innovation school. Key areas of focus consisted of curriculum, budget, school schedule and calendars, staffing, professional development, and school district policies.

Superintendent's 120-Day Entry in the Salem Public Schools Report

Superintendent Smith informed the School Committee that she updated her entry day from 90 to 120 after re-reviewing the actual amount of days. Superintendent Smith talked about her 120-Day entry in the Salem Public Schools and presented on five areas of focus: Understand Salem Culture and Values, Strengthen School Committee Admin Relations, Build Relationships With Schools and Community, Clarify Administrative Roles and Functions, and Improve Critical Systems, Processes, and Functions.

The School Committee believes that the district must ensure that instructional materials support the district in meeting its stated goals.

The task of selecting instructional materials for programs will be delegated to the professional staff of the school district and approved by the Superintendent. When adopting and regularly evaluating instructional materials, professional staff must consider the following:

- 1. Instructional materials should be aligned with state and district standards and learning outcomes and should support district attainment of stated goals.
- 2. They must provide for all students an effective basic education that does not discriminate on the basis of race, age, color, religion, <u>ancestry</u>, national origin, sex, gender identity, physical disabilities, sexual preference or housing status.
- 3. They must allow sufficient flexibility for meeting the special needs of individual students and groups of students.

State law provides the following:

Every child shall have a right to attend the public schools of the town where he/she actually resides, subject to the provisions of Chapter 76. All enrolled students shall have equal access to the general education program and the full range of any occupational/vocational education programs offered by the district.

In compliance with state and federal laws, the Salem Public Schools maintains a nondiscrimination policy. No child shall be excluded from or discriminated against in admission to Salem Public Schools, or in obtaining the advantages, privileges and courses of study of our schools, regardless of race, color, sex, gender identity, religion, national origin, ancestry, sexual orientation, disability, or housing status. This policy provides equal access to courses and programs, counseling services, physical education and athletics, vocational education, instructional materials, extra-curricular activities, and access to restroom and locker room facilities.

STUDENTS AND INSTRUCTION 5000 INSTRUCTIONAL PROGRAM 5200 STUDENT RECORDS 5215 State law provides that the schools must furnish any student or former student with a transcript of his/her record as a student; the original to be furnished without charge and copies furnished at limited charges established by the law.

These records are maintained in the best interest of the student, and with a concern for the school's right to collect certain information in order to carry out its educational function in the best possible manner. The school department will make every effort, within reason and consistent with state and federal regulations, to inform parents and students about the kinds of information collected or that will be collected and about their rights under said regulations. A parent may request a review of their child's student record and request a revision of that record.

All records and documents regarding discipline shall be removed from the student's file and destroyed upon the student's graduation or permanent withdrawal from the school,
