#### **Superintendent's Report**

Before discussing the agenda items for the Superintendent's Report, Dr. Zrike asks to take a moment of silence for the Salem High School senior who recently passed and reflect on the student and family and all the students and staff impacted by this loss.

#### a. Reflection from the Teacher of the Year- Ms. Marta Garcia

Ms. Garcia begins her presentation by noting the first part of her presentation she will speak about her first few years of service. She notes October 6th, 2021 was known as Marta Garcia Day at Witchcraft Heights Elementary School. Throughout the last year, she was invited to multiple organizations and institutions to participate in public speaking as well as podcasts. Ms. Garcia also notes that the Witchcraft Heights students will also have their self portraits displayed at the White House.

Ms. Garcia notes she considers her job as a teacher as a form of activism because teaching languages is related to cultures and identity. Teaching goes beyond the walls in many different ways. Teaching is advocacy and activism.

Ms. Garcia explains the structure she uses in her classes to help with her student's needs. The do-nows are graphic organizers journaling. The center is reading vocab hand-on activities. The reading or video on current unit or topic and the group discussions which is a whole group debrief. Ms. Garcia's favorite teaching tools to use are chromebooks/ipads, books in color, visual centers, graphic organizers and binders. The data takes the form of student reflections, feedback from parents and my own observations in the classroom. It is crucial to provide students with the tools to be part of the community and share their stories because their stories are important.

#### **b.** Technology Update

Mr. Marc Leblanc notes updates on where technology stands at Salem Public Schools. As of right now, we have three arms of our technology department. We have our technical support department led by Carlos Arias Reyes and four technicians. We also have digital learning coaches. A Data and Apps Manager as well as data analyst and strategist.

Mr. Leblanc notes the technical support team makes sure that every student has a working device as well as a google and aspen account. This team also oversees our staff technology deployment and support and oversees classroom technology management. Recent projects included upgrading staff laptops as well as upgrading classroom display tech devices.

Mr. Leblanc notes the digital learning team who provide staff training, foster digital citizenship, incorporate technology within instruction, touch view training, k-5 tech competencies, and CMS classroom tech enhanced lessons. ClassLink is the single sign-on rostering system. Data and reporting are SIMS, EPIMS, SCS, and SSDR are reports submitted to the state.

Mr. Leblanc notes future products are GoGuardian to view students' chromebooks to keep an eye on students' work. Gives teachers the ability to push to students what tasks need to be done.

Dr. Pangallo asks how we are protecting our students' identity online.

Mr. Marc Leblanc notes anything that is not covered under the child protection act is safe. Not any app can be downloaded from the web store. Secure web extension online and off sight at home using our school technology. Students can only log into chromebooks using their google account that is provided by the SPS IT department. Many of the play store apps are turned off.

Mr. Cruz asks about cyber theft and our controls. Are their refreshers being performed?

Mr. Leblanc notes we have not in the past but we are in collaboration with the city IT department to do training on cyber theft. We do not have any on site local servers any more which is a huge help to avoid cyber theft.

#### c. Staffing Report

Dr. Zrike notes the personnel report and unfilled positions starting July 1st. Many of these unfilled positions are grant funded and we are still looking for para's as well as teachers who are temporarily on leave.

Mr. Cruz notes it would be great for winter outreach and how we can better align will intervals for recruitment.

Mr. Fleming asks Ms. Jill Conrad if we are performing exit interviews now.

Ms. Jill Conrad notes we are consistently sending exit interview surveys and we also have Dr. Ruben Carbona followed up with exit interviews as well this year.

Dr. Zrike notes a lot of staff members will reach out to him directly to schedule an exit interview as well.

Ms. Jill Conrad notes the volume of staff turnover may be reflected where the job market was very competitive so there were some cases where people said they were taking a job and then ended up not taking the job.

#### **Student Representative Report**

Ms. Natalia Feliz notes our rough draft is building the buddy system. Start working with 7th and 8th graders, after school activities to join in on. Transportation is a factor that is trying to be resolved. The new mentor, Ms. Wilkson, was met and how to better build our community within.

Dr. Pangallo asks if the students will need transportation. Ms. Feliz notes transportation is something we would have to further discuss.






