### Purchase Description & Scope of Services

I.A.: The anticipated start date of the contract is October 1, 2021, not August 31.

The number of municipalities and students has changed slightly (Beverly -2, Lowell -1, Wilmington +1, Woburn +1, Winthrop +1). An updated pages 24-25 is found at the end of this addendum, or bidders may amend the previous bid form.

#### **Questions & Answers**

- 1. Is funding already set aside or is this to get funding? *Funding is already in place*.
- 2. Vehicles used in this bid are school pupil transport vehicles, as defined by MGL Ch90, Section 7D. Where can this information be obtained this so we know if it is BUS, VAN, Mini Van, or sedan? *The relevant chapter can be found at* https://malegislature.gov/Laws/GeneralLaws/PartI/TitleXIV/Chapter90
- 3. Are brokers allowed to participate? If so, would they need to get written consent before submitting their bid?

The City declines to answer.

- 4. Can you tell us the drop off and pick up times for the transportation?

  Times will be determined by the successful vendor after being given details by the School Department.
- 5. Does a vendor currently hold the contract? If so, can you release that information? *The current provider is Bay State Transportation.*
- 6. Can you be more specific about the locations the children will be transported? *Students will be transported to the various schools of Salem.*
- 7. Can you provide pick up and drop off locations (schools (elementary, high, etc.) Student addresses will not be provided as part of this bid. School addresses may be found at <a href="https://www.salemk12.org">www.salemk12.org</a>.
- 8. Can you provide length of time students can be on the vehicle? *No more than sixty (60)*
- 9. Can students be multi-loaded into vehicles? *Multiple students may ride in each vehicle.*
- 10. Are we allowed to provide an alternate bid? For example, per day, per vehicle? No alternate bids will be accepted. The current bid does incorporate a per day rate.
- 11. Can kids from different towns be put in vehicles together?

  Yes, as long as the total commute time does not exceed sixty (60) minutes for any given student.

Options to renew the contract for the second and third years will be at the sole discretion of the Salem School Committee.
- 4. All bid prices are to be indicated in ink (or typewritten), and written in both longhand and numerals. If there appears to be discrepancy between these figures, the price indicated in longhand shall prevail.
