ZONE 1
April 4 – April 8, 2024

Street sweepers will be in each neighborhood from **7:00AM to 3:00PM.** During that time period a No Parking Tow Zone area will be in effect. Temporary orange tow zones will be posted throughout each neighborhood and all cars must be removed from both sides of the street so that sweeping can take place.

Please remember to move your car off the street so it will not be towed. You will be able to move your vehicles back onto your street once you have seen the sweeper has cleaned your roadway.
