WINTER ISLAND BOAT STORAGE TERMS AND CONDITIONS PAGE TWO

- 1. Boat Hauling is an additional service and will be assigned by the Harbormaster Department according to Vessel size and type. Payment will be made directly to the hauler by owner at time of both fall hauling and spring launch.
- 2. Boats stored at Winter Island are arranged to maximize use of available space. Therefore, once a boat is stored for the off-season, it may not be moved out prior to the end of the storage period without the approval of the Harbormaster or his designee.
- 3. The Boat Storage season at Winter Island begins November 1st each year and concludes May 15th of the following year (or at Harbormaster's schedule/direction).
- 4. All boats and trailers shall be removed no later than May 15th each year (or at Harbormaster's direction).
- 5. Arrangements to move boats and trailers must be made with the office of the City Harbormaster.
- 6. If a boat and/or trailer remains unclaimed for one month, on or about June 15th, the owner shall receive notice by registered mail of the city's intent to take possession of the boat and trailer. If the owner of said property refuses or fails for a period of ten days following said receipt to remove the property, the city may sell the property, excepting money unclaimed, by public auction, notice of the time and place of sale, with a description of the property to be sold, first being given by publishing the same once in each of three successive weeks in a newspaper published in such city.
- 7. Before any boat may be stored at Winter Island, the owner must have paid all current City of Salem excise tax and mooring fees relative to the boat and trailer. Failure to remain current with excise taxes and mooring fees will result in the owner not being allowed to store his or her boat on City property.
- 8. The City, its agents, officers and employees assume no responsibility for any boat or trailer stored at Winter Island and will not be responsible for any damage to a boat or trailer or equipment on the boat including, but not limited to, fire, theft, vandalism, freezing and storms.
- 9. The owner may not perform maintenance on the boat or trailer while stored at Winter Island outside posted hours.
- 10. The owner must conduct him or herself at all times when at Winter Island so as not to create any annoyance, hazard, or nuisance to other boaters or visitors.
- 11. Each owner must clean up and remove any debris or other material when the boat is taken out of storage in the Spring. Failure to adequately clean up any refuse will be a cause for denying the right to store a boat in the future.
- 12. The owner shall provide proof of insurance and agrees to indemnify and hold harmless the City, its agents, and employees from and against any liability, damages, losses, claims, demands, and expenses what so ever, including attorneys fees which may arise directly or indirectly from storage of the boat and trailer at Winter Island.
- 13. In the event that the owner shall sell or otherwise transfer the boat and or trailer, while it is stored at Winter Island, the owner shall immediately notify the Harbormaster in writing.
- 14. These terms and conditions shall be binding upon and to the benefit of the heirs, executors, administrators, and assigns of the owner.
